Three years ago LSE IDEAS was still a fledgling research centre with very high academic ambitions, but without the funding or the administrative resources to realize all of our plans. Today we are in a much better position to make things happen. Our funding is substantially improved, not least because of the generosity of our friends and supporters outside of the LSE. Their continuing help with making LSE IDEAS a research centre of global importance has been essential to our growth. We are also a much better managed centre than before. Our centre manager, Dr Emilia Knight, and her staff provide first-class support for our academic endeavours. We can take pride in offering an environment for research that is not only intellectually stimulating but also well organised in terms of how the centre is run.


Over the past three years IDEAS has expanded its academic brief considerably. When we started up in 2008, most of our associates came from political science or history, and we still have very close relations with the LSE's International Relations and International History departments. Now, the intellectual concerns of colleagues from these two departments are part of a much larger mosaic within LSE IDEAS. Today there are people from all over the School attached to the centre, from Economics to Social Psychology and Anthropology. We are proud to be a hub for research on international affairs for colleagues from many different departments and many different schools of thought. And we are especially proud that many of us now engage in different forms of interdisciplinary work on important issues.

LSE IDEAS is a research centre within a great university, and it draws on all the advantages it gets from being associated with teaching and research on a broad scale. London has plenty of new institutions dealing with international affairs. LSE IDEAS is unique in the sense that it thrives on its association with the world's foremost social science university. Part of its success is that it has helped make on-going research at LSE more relevant to the policy debate. That we were listed among the world's most influential foreign policy think tanks last year is therefore not just a recognition for IDEAS but for the whole LSE community.

Top level research and debate is often as much about involvement and sheer fun as it is about long hours spent in libraries and archives. Our sense of ourselves is that IDEAS represents this ideal to the max. Hardly a day goes by without there being some kind of event, discussion, seminar, lecture, or just impromptu debate. And the socials, at IDEAS or a nearby pub, are sometimes as important for developing suggestions and points of view as are the more formal settings.

Nobody represents the IDEAS ideal of mixing serious debate with fun as much as my colleague Mick Cox. Mick and I set up the centre together five years ago, and he remains founding co-director of IDEAS after becoming emeritus professor of international relations last year. Mick also directs the centre's new executive MSc degree programme in Diplomacy and International Strategy. As you will see from this report, the new degree has been an outstanding success, helping train the next generation of top leaders in international affairs on a global scale.

As often happens when you are doing good stuff and having fun, the number of people who join up outgrow the facilities. This spring we realised that IDEAS could no longer be accommodated in Columbia House if we were to expand further. We therefore moved to the LSE Towers this summer, where we are found on Floors 9 and 10. I hope to see you there, or at one of the many events IDEAS organises around the School, in London or elsewhere.

Professor Michael Cox, Founding Co-Director



Michael Cox holds a Chair in the Department of International Relations at the London School of Economics. In 2004 he helped establish the Cold War Studies Centre, and in 2008 IDEAS, a foreign policy centre based at the LSE which aims to bring the academic and policy worlds together. In a 2012 international survey, IDEAS was ranked 4th in the world amongst the best university affiliated think tanks. Since joining the LSE he has also acted as Academic Director of both the LSE/PKU Summer School and of the Executive Summer School. In 2011 he launched a new Executive

Masters in Diplomacy and International Strategy designed to teach senior foreign policy practitioners.

Professor Cox has held several senior professional positions in the field of international relations including Chair of the European Consortium for Political Research (ECPR); member of the Executive Committee of the British International Studies Association and of The Irish National Committee for the Study of International Affairs; Associate Research Fellow Chatham House, London; Director of the David Davies Memorial Institute for the Study of International Politics, Aberystwyth; Senior Fellow Nobel Institute, Oslo; Chair of the United States Discussion Group at the Royal Institute of International Affairs; and Transatlantic Fellow at the Royal United Services Institute London. He also serves on the editorial board of several academic journals and has been editor of several leading journals in International Relations, including the *Review of International Studies*; *International Relations*; *Cold War History*; and *International Politics*.

Professor Cox is a well-known speaker on global affairs and has lectured in the United States, Australia, Asia, and in the EU. He has spoken on a range of contemporary global issues, though most recently he has focused on the role of the United States in the international system, the rise of Asia and whether or not the world is now in the midst of a major power shift.

Professor Cox is author, editor and co-editor of several books including *Superpowers at the Crossroads* (1990); *US Foreign Policy after the Cold War: superpower without a mission?* (1995); *Rethinking the Soviet Collapse* (1998); *The Eighty Years Crisis: international relations, 1919-1999* (1998); *The Interregnum: controversies in world politics, 1989-1999* (1999); *American Democracy Promotion* (2000); *E.H. Carr: a critical appraisal* (2000); *A Farewell to Arms: from long war to long peace in Northern Ireland* (2000; 2nd edition 2006); *E.H. Carr: The Twenty Years' Crisis: introduction to the study of international relations* (2001); *Empires, Systems and States: great transformations in international politics* (2002); *How Might We Live? Global ethics for a new century* (2002); *The International Relations of The Twentieth Century: 8 volumes* (2007); *Global 1989: Continuity and Change in World Politics* (2010); *Soft Power and US Foreign Policy* (2010) *Introduction to International Relations*, (2012); *US Foreign Policy* (2006; 2nd edition 2012); *US Presidents and Democracy Promotion* (2013); *International Relations of the Cold War* (2013); *The Rise and Fall of the American Empire: From Bush to Obama* (2013).

Professor Odd Arne Westad, Director



Arne Westad is professor of international history and an expert on contemporary international affairs. He is the general editor of the three-volume *Cambridge History of the Cold War* and an editor of the journal *Cold War History*. His latest book is *Restless Empire: China and the World since 1750*. His previous book, *The Global Cold War*, won the Bancroft Prize, the Harrington Award of the American Political Science Association, and the Akira Iriye International History Award. It was listed by the Council on Foreign Relations as one of the five most important books on international affairs for 2005/06. It has been translated into fourteen languages.

Born in Norway, Professor Westad studied history, philosophy and modern languages at the University of Oslo and received his PhD in history from the University of North Carolina at Chapel Hill. During the 1980s he worked for several international aid agencies in Southern Africa and South Asia. He has taught at the University of North Carolina and at Johns Hopkins University and served for eight years as Director of Research at the Norwegian Nobel Institute. Since 1998 he has been in the Department of International History at LSE, where he teaches Cold War history and the history of East Asia. He served as Head of Department 2004-07.

Since 2007 Professor Westad has helped build LSE IDEAS, the LSE's centre for the study of international affairs, diplomacy and strategy, of which he is now co-director. The centre is the hub for nine separate research programmes, ranging from Transatlantic Relations to African International Affairs and Cold War Studies. It also helps run the LSE's double Masters degree in International Affairs with Peking University, and has set up an executive Masters degree in Strategy and Diplomacy. In addition to its research and teaching, LSE IDEAS works with several foreign ministries on matters of policy planning and development.

Professor Westad has held visiting fellowships at Cambridge University, Hong Kong University, New York University and the University of Venice. He has been the recipient of major grants from the John D. and Catharine T. MacArthur Foundation and the British Arts and Humanities Research Council. He has served as the international co-ordinator of the Russian Foreign Ministry's Advisory Group on Declassification and Archival Access and has advised several other governments on such issues. He now heads the British Academy's documentary project on British-Russian relations during the Cold War. He is also widely known as a reviewer, lecturer and external examiner. In 2000, Professor Westad was awarded the Bernath Lecture Prize from the Society for Historians of American Foreign Relations. He was elected a Fellow of the British Academy in 2011.

Professor Westad often lectures to general audiences in different parts of the world on key issues in international affairs, such as China's foreign policy and the situations in Korea, Afghanistan and Iran.

Sir Colin is an expert on
European affairs. He was
in charge of European and
Economic Affairs in the FCO
and then served as Ambassador
to the Netherlands. He has also
held senior positions in the
Cabinet Office. He currently
advises governments that are
preparing to take over the
rotating presidency of the EU.

Prof Christopher Coker

Christopher Coker is Professor
of International Relations. He
is also a fellow of the Tokyo
National Institute of Defence
Studies, the Moscow School
of Politics and the Washington
Strategy Seminar, and has twice
served on the Council of RUSI.
He has written extensively on
strategy and lectures at defence
academies around the world.

Sir Richard Mottram

Sir Richard is an expert on
defence, security, strategy and
planning. He was one of Britain's
top civil servants, heading
several departments, including
the Ministry of Defence, and
Security and Intelligence in
the Cabinet Office. His current
roles include Chairman of the
Defence Science and Technology
Laboratory.

Mr Jonathan Powell

As a British diplomat Jonathan
Powell was closely involved in
negotiations with the Chinese
over Hong Kong and German
unification. As Chief of Staff
to Prime Minister Blair he
played a key role in reaching an
agreement with the IRA on a
political settlement in Northern
Ireland.
He is currently Managing
Director at Morgan Stanley.

Prof Patrick Salmon

Professor Salmon is the Chief
Historian at the Foreign and
Commonwealth Office. His
research focuses on the
history of Scandinavia and
twentieth-century international
relations. He is the author of
Scandinavia and the Great
Powers 1890-1940 and co-editor
of Documents on British Policy
Overseas and Slavery, Diplomacy
and Empire Britain and the
Suppression of the Slave Trade,
1807-1975.

Mr Cato Stonex

Cato Stonex graduated from
the LSE, of which he is now a
governor. In 1986, he joined
the European government
bond trading department at
Morgan Grenfell. In 1989 he
joined J. Rothschild Investment
Management and began his
association with Nils Taube and
John Hodson. Together they
formed THS Partners in 1997.

Lord Wallace of Saltaire

Lord Wallace is an Emeritus
Professor in the Department of
International Relations at the
London School of Economics
and has a long distinguished
record in British politics. He
was made a peer in 1995 and
became the Liberal Democrat
spokesman on Foreign Affairs
and Defence. He subsequently
sat on the Select Committee on
European Communities and was
Chairman of the Sub-Committee
on Justice and Home Affairs
from 1997-2000. 2004 saw him
elected Deputy Leader of the
Liberal Democrat Peers.

Mr Emmanuel Roman

Emmanuel Roman has wide-
ranging experience across
the financial services sector.
Emmanuel joined Goldman
Sachs in 1987 where over the
years he worked in the fixed
income, investment banking and
capital markets areas. In 2005,
Emmanuel joined GLG Partners
LP as co-CEO. In 2010 he also
became the COO of MAN, a
group-wide role with prime
responsibility for integrating its
acquisition of GLG. He joined
the Board of MAN Group Plc in
2011.

BRIEF SUMMARY

The LSE IDEAS **Africa International Affairs Programme (AIAP)** is designed to promote greater understanding of the extent to which the recent past in Africa is particularly relevant to domestic policies, inter-state relations, as well as the continent's relationship with the world at large. It is broadly divided into five geographic parts, mirroring the regional economic communities - the Magreb (The North Africa Initiative); the Horn; Southern Africa; Central and West Africa. In all of these areas it promotes collaboration with regional scholars, as well as research and academic institutions, through a series of seminars and conferences. AIAP's activity is geared towards fulfilling three main objectives. First, it aims to promote knowledge on Africa through an extensive series of events, such as public lectures, graduate workshops and working seminars. Second, it acts as a hub, by providing an active electronic network for scholars, practitioners and policy makers. The third key component of AIAP's activity is to support both, established and emerging African scholars and foreign researchers wishing to further their studies in contemporary history and politics in the African region.

AIAP has 10 Associates, including Thandika Mkandawire, Chris Saunders, Vladimir Shubin and Anna-Mart van Wyk.

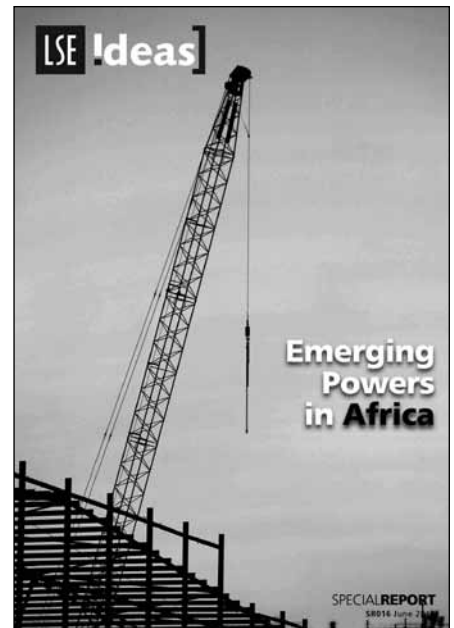

African Research Fellowship

AIAP is delighted to announce that the first African Research Fellowship to be held at LSE IDEAS has been awarded to **Dr Sergio Chichava from the Instituto de Estudos Sociais e Economicos (IESE)**, Maputo, Mozambique. During the fellowship period from 1 January 2013 until 30 June 2013, Dr Chichava's research will focus on the topic of the Rising Powers in Africa, and in particular the role of China and Brazil in Mozambique's agriculture sector. The LSE Annual Fund has awarded a further £18,000 to the AIAP for the development of the Programme.

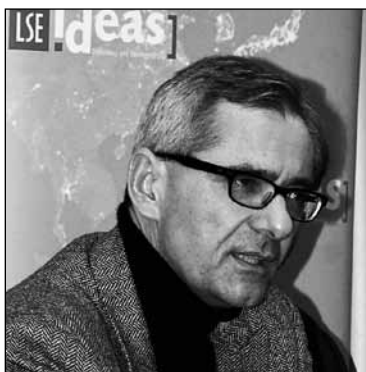

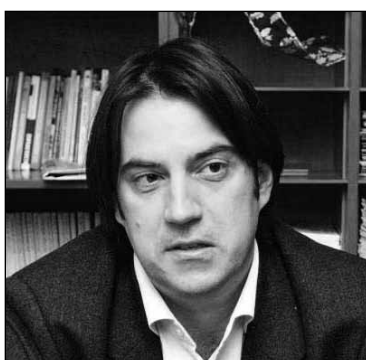

BRIEF SUMMARY

The objectives of the **Balkan International Affairs Programme (BIAP)** are to promote the understanding of the troubled past of the region, to assist in the search for the answers to the challenges of today and to contribute to defining a vision of the Balkan future. It aims to achieve these goals by engaging in debates on current issues and challenges and – together with Balkan institutions, scholars and practitioners – working to formulate specific and qualified responses. As a result, the BIAP's activity is geared to provide regional governments, academic and research institutions, and NGOs with expertise and assistance; to conduct strategic studies and leadership programmes; and to facilitate research through fellowships at the LSE or in our partner institutions for regional senior scholars, post-doctoral fellows and graduate students.

This year the BIAP will be transforming into the **Southern Europe International Affairs Programme (SEIAP)**. The aim of SEIAP is to study how the contemporary political, economic and social features of the Southern European region were shaped. This interdisciplinary initiative is made up of historians and political scientists interested in exploring interactions in domestic, regional and international events and developments that had wide-lasting impact on Southern Europe.

The BIAP has 8 Associates, including Dr Marietta Stankova, Prof Evanthis Hatzivassiliou, Dr Effie Pedaliu and Dr Vladimir Unkovski-Korica.

HIGHLIGHTS

Events

- The SEIAP, in collaboration with the Instituto de História Contemporânea, is organizing a second workshop entitled: *The Road to Democracy in Southern Europe: The International Dimension*. This will take place in Lisbon on 22nd November 2013.
- To mark its official launch, the SEIAP will host leading academics and policymakers at a day-long conference, followed by a public lecture with Dr Javier Solana entitled: *The EU in the eye of the Storm* on 14th October 2013. It will examine the shared economic and strategic challenges faced by crisis-stricken Southern Europe.
- The public seminar series '**History as a Burden to Shared History and Beyond**' (January – March 2013) brought together historians and practitioners, with the aim of advancing the integration of historical legacy into contemporary experience as 'lessons of history'.
- The *International Dimension of the Southern European Dictatorships* workshop was held in June 2012 at the LSE. It examined the the Greek, Portuguese and Spanish authoritarian regimes in the early 1970s, and attracted several prominent international scholars as well as experts on the region.
- The **Non Aligned Movement (NAM)** conference, held in Belgrade (May 2012), successfully engaged established and younger scholars from around the world, who redressed the role and contribution of a unique Cold War alternative and Third World platform.
- In January 2012 '**The Balkans 2020**' workshop brought together 25 academic and experts from different fields, who examined the prospects for the region in 2020.

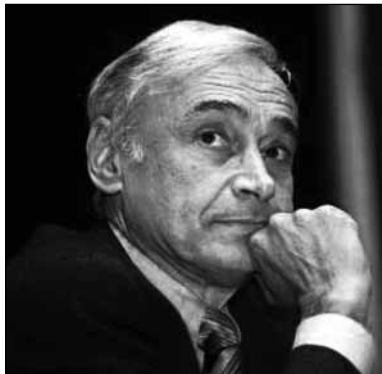

BRIEF SUMMARY

The LSE IDEAS **Cold War Studies Programme (CWSP)** is the main British centre for advanced study and research on the Cold War, its historical origins and its contemporary repercussions. The Programme concentrates its research on a series of programmes dealing with the Cold War in Europe and in the Third World. It cooperates closely with a number of academic and government institutions and other Cold War studies centres worldwide, notably in Washington, Moscow, Florence, Beijing, and Tokyo.

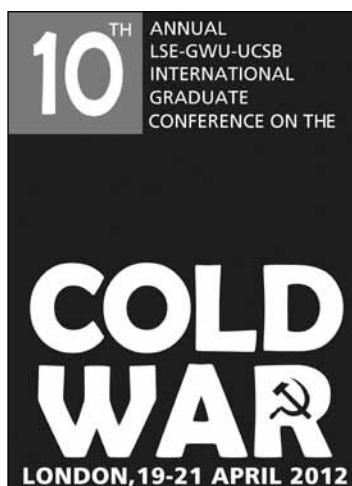
The CWSP attracts postgraduate students, postdoctoral associates, research fellows, and visiting scholars from Britain and abroad to study and conduct research in a unique interdisciplinary environment, and to work with international organisations, government institutions, and other agencies worldwide.

The CWSP has 39 Associates, including Prof Mary Elise Sarotte, Prof Mary Kaldor, Prof Georges-Henri Soutou and Prof Lord Peter Hennessy.

HIGHLIGHTS

Events

- In November 2013, the CWSP is to host a one-day conference encouraging academics and practitioners to explore the influence of the Cold War on the enlargement of the European Union and to discuss the future of EU enlargement. The event will be followed by a public lecture by former Prime Minister of Bulgaria Sergei Stanishev and the launch of the CWSP Special Report, 'The Crisis of EU Enlargement'.
- In March 2013, an international conference, 'Fifty Years without JFK: Rethinking Global Diplomacy', was jointly organised by the CWSP and the Institute for the Study of the Americas. Nine academics and nine PhD candidates from around the world shared their latest research on JFK's foreign policy. Invited speakers included Professor Sir Lawrence Freedman, Professor Matthew Jones, and Dr Andrew Preston.
- In October 2012, the CWSP organised a panel discussion to mark the 50th anniversary of the Cuban Missile Crisis, focusing on the seldom-heard Cuban perspective of the crisis. Speakers included Professor Carlos Alzugaray Treto (University of Havana), Professor Hal Klepak (Royal Military College of Canada), and Professor Antony Kapcia (Nottingham).

- On 19-21 April 2012, the CWSP hosted the 10th Annual LSE-GWU-UCSB Graduate Conference on the Cold War. The foremost international conference on the Cold War and late 20th century international history, it showcased the work of 23 PhD students from across the world.
- In February 2012 Jorrit Kamminga, Director for Policy Research at the International Council on Security and Development (ICOS), introduced and discussed his film, 'Afghanistan, Land of Wonders' (2009).
- The panel discussion 'The Soviet Union's Collapse: Causes and Consequences' was held in January 2012. Panellists included Andrey Grachev, confidant of Mikhail Gorbachev, Sir Rodric Braithwaite, British Ambassador to Moscow from 1988 to 1992, and Prof Margot Light, LSE Professor Emeritus. Prof Michael Cox chaired the event.
- Other events included: a talk by Sarah Snyder on the influence of the 1975 Helsinki Final Act and the human rights movement that developed in its wake (October 2011); a round-table discussion with the FCO about James Hershberg's latest book 'Marigold', an in-depth account of one of the peace initiatives for the Vietnam War (May 2012); and the ongoing, bi-weekly seminar on the Cold War (HY510), organised in collaboration with the LSE Department of International History.

Video interviews are now integrated into our webpages, and podcasts from events allow for global dissemination.

BRIEF SUMMARY

The LSE IDEAS **East Asia International Affairs Programme (EAIAP)** studies the relationships among the three countries in the region (China, Japan and South Korea), as well as those between the region as a whole and the main outside powers. It seeks to discuss the changing nature of East Asia's international affairs dynamic through an active engagement with academics, practitioners and representatives from businesses and organisations within the region and elsewhere. Since its launch in 2010, the EAIAP has become one of the most prominent East Asia programmes in the UK, renowned for its sharp analyses and up-to-date coverage of regional affairs. The programme's research associates, who are among the very best regional experts in the UK, Europe and the East Asia region, provide a constant source of engagement for fruitful discussion. The EAIAP also hosts an advanced and unique training programme in international affairs for Chinese senior diplomats, which is supported by the British Foreign Office and the Chevening Foundation.

The EAIAP has 23 Associates, including Prof Shaun Breslin, Prof Françoise Godement, and Prof Rana Mitter.

- The workshop 'Is China Inc. Conquering the World?: The impact of Chinese Outward Investments to the World' eight industrial experts and veteran journalists, including former Head of UKTI Sir Andrew Cahn and former Guardian journalist Ms Isabel Hilton, and enjoyed lively discussions on each panel. (June, 2013)
- The workshop on *Grand Strategy: China's Foreign Policy in a Changing Global Order* was jointly hosted by the EAIAP together with the King's College China Institute, and was led by fifteen top experts on China, from both the UK and Europe. (January, 2012)
- The roundtable discussion on '*The Post Kim Jong-Il North Korea and Its Impacts on Regional Order*' with Mr Aidan Foster-Carter was the first event related to North Korea organised by a UK-based think tank or research institution. (October 2012)
- The public lecture '*The End of the Party*', given by Prof Rana Mitter from Oxford University, focused on the Ninety Year history of Chinese Communist Party and the challenges it faces in the future. (October 2011)
- Other events have included Jonathan Fenby's launch of his recent book '*Tiger Heads, Snake tails: China today, how it got there and where it is heading*' (24 April 2012); and the public lecture on *China's Geo-economic Strategy* by Prof Arne Westad and Guy de Jonquieres. (May 2012)
- The roundtable discussion on *China's New Leadership Hopes for Reform and Fear of Uncertainty* was jointly organised by the EAIAP together with the Asia Research Centre. (February 2013)





Publications

The programme's Special Report on China's Geo-Economic Strategy was published in June 2012. The report assesses the primacy of economic interests in the China's foreign policy, analyses how China views the strategic dimensions of investments and trade, and whether the world really sees China having a coherent strategy. The Report has enjoyed its sweeping success and covered widely by media worldwide

The UK edition of Prof Arne Westad's book *Restless Empire: China and the World since 1750* was launched on November 2012 with a public lecture at the LSE. In the book, Prof Westad argues that China's role in international affairs over the past 250 years has been determined by the country's restless irresolution as well as by its immense capacity for change.

The Chevening Scholar Programme

In September 2008, the Programme welcomed its first visiting fellows from the CCP Central Party School and the International Department of the Chinese Communist Party. Since then, fellows including Dr Liu Dong (CCP Party School), Ms Zhao Xuelan (MFA) and Mr Zhou Guo Hui (IDCPC) have been focusing their research on both Party diplomacy and China-Africa relations.

Internet presence

The Programme runs a very active and up-to-date blog, named *Confuciana*, which has been publishing three posts each month since it was first launched, in July 2011. Topics cover all major debates on what has happened in the region and beyond. The blog has become a major platform for debate on current affairs in the region.

FUNDING TO-DATE

The EAIAP has raised £173,237 including £99,737 from the ESRC for a 3-year project entitled *China, Hong Kong, and the Long 1970s in Global Perspective*.

BRIEF SUMMARY

The driving force behind the LSE IDEAS **Latin America International Affairs Programme (LAIAP)** is the realisation that both the Latin American chapter of the Cold War and the implications of the Cold War on the region continue to be fragmented areas of study, relatively neglected and waiting to be more fully explored. Building on LSE IDEAS' combined strengths in the study of International History and International Relations, the LAIAP aims to facilitate dialogue, stimulate research and overall promote a better understanding of the way in which Latin America's past impacts on its present. LAIAP accomplishes this through a set of activities that primarily focus on different types of events and a strong web presence. As a result, the programme has become a hub not only for LSE students and researchers with an interest in Latin America, but also within London.

LAIAP has 19 Associates, including Dr Gian Luca Gardini, Dr Guy Burton, Dr Tanya Harmer, and, Dr John Hughes.

HIGHLIGHTS

Events

Each year LAIAP organizes various events, which largely fall into two categories: regular medium-sized events – primarily the *IDEAS Latin America Research Seminars* – and annual or biannual high-impact events – usually one- or two-day conferences. Both types of events seek to fulfil the LSE IDEAS purpose by creating forums for the discussion of international affairs research pertaining to Latin America and generating links between members of the broader Latin America research community and LSE IDEAS.

- The *IDEAS Latin America Research Seminars* are the LAIAP's flagship event series. During the Michaelmas and Lent Terms, Research Seminars take place on a weekly or bi-weekly basis and feature a wide-range of topics relating to the comparative politics and international affairs of Latin America. Presenters include both PhD students and faculty at LSE, as well as external speakers.
- The LAIAP organizes *high-impact* events on an annual or biannual basis. These are usually one- or two-day conferences that include a number of external participants and are funded through outside sponsorship. In 2011, LAIAP hosted the conference on *Brazil and the Americas in the 21st Century*, which was followed by a one-day workshop on *Latin America in the 21st Century*. In 2012 it co-organised the *LSE Mexico Week*, a four-day conference on the 2012 Mexican Federal Elections. The LAIAP also hosted *UK-Argentina, Is There a Way Forward?*
- In 2013, high impact events have included, *Towards a Paradigm Shift in Latin American Migration and Asylum Policies? Argentina and Mexico in Comparative Perspective* (January); *The Challenges to the Democratization Process in Latin America* (February); and *New Directions in Latin American Integration: The Alianza Pacifico* (March)

BRIEF SUMMARY

The **Russia Studies Programme (RSP)** was set up at IDEAS in 2010 to study the history of Russia's international relationships, both regionally and globally. It seeks to discuss the nature of Russia's imperial international affairs with particular interest in the historical development of Russia's presence on the international stage and what it can tell us about the future; in analysing the links between the domestic and foreign affairs of the region and in looking at the interaction between different aspects of such relationships in the region: trade and technology, security and military strategy, and culture and 'soft power', among others. To promote this discussion, the RSP brings together interested parties through a number of academic associates, a Visiting Fellowship Programme and different types of events.

The RSP has thirteen Associates, including all former Paulsen Visiting Fellows.

- The RSP organises an annual lecture, with support from the Schapiro Fund. This is a public lecture given by a leading Russian historian, which focuses on a historical topic with contemporary relevance. The Paulsen Fellowship Programme

Thanks to a generous donation from the Frederik Paulsen Foundation, the RSP established a five-year Visiting Fellowship Programme. It brings twenty early-career academic historians from a wide range of Russian universities, with particular emphasis on those from the regions, to study as Fellows at LSE IDEAS for a period of one to three months. These historians are working in the history of Russian international relations, diplomacy and strategy, broadly defined, between 1700 and 1917. The Programme is now in its fourth year and has already produced fourteen Fellows from universities all across Russia.

The Programme is endowed to allow Fellows to carry out their research in the UK, not only in the archives and libraries in London, but other repositories elsewhere in the UK. Fellows have therefore been able to make use of specific collections in Oxford, Cambridge, Edinburgh and Belfast. Other specialised institutions have also been an important aspect of certain projects, including LSE's own Gender Institute and the Women's Library in London to the British School Museum in Hitchin. Fellows have participated in conferences at LSE and attended IDEAS lectures and seminars. In addition, by providing them with a base within IDEAS, the Fellows are encouraged to meet and discuss their work with other young researchers.

BRIEF SUMMARY

The **Southeast Asia International Affairs Programme (SEAIAP)** aims to explore both the internal dynamics of the Southeast Asia region and the region's external relations with world powers, especially China and the US. The programme specifically focuses on: the regional integration in the context of the Association of Southeast Asian Nations (ASEAN); the growing importance – both at a regional and at a global level – of the region's emerging economies and financial markets; the political changes and democratic transitions of Southeast Asian political systems and their international accountability; the region's diplomatic and strategic context. The programme's major purpose is to integrate the perspectives of scholars and practitioners in order to create a fertile environment of discussion regarding the abovementioned topics.

BRIEF SUMMARY

The **LSE IDEAS United States International Affairs Programme (USIAP)** focuses on how the United States acts in the world, and in particular, the structural role of the United States in the current international system. In taking this systemic approach to the role of the United States, the programme's research will seek to move beyond the traditional distinction between 'hard' and 'soft' power and instead offer a more holistic understanding of American power, paying particular attention to the structural forces that underpin the United States' global role.

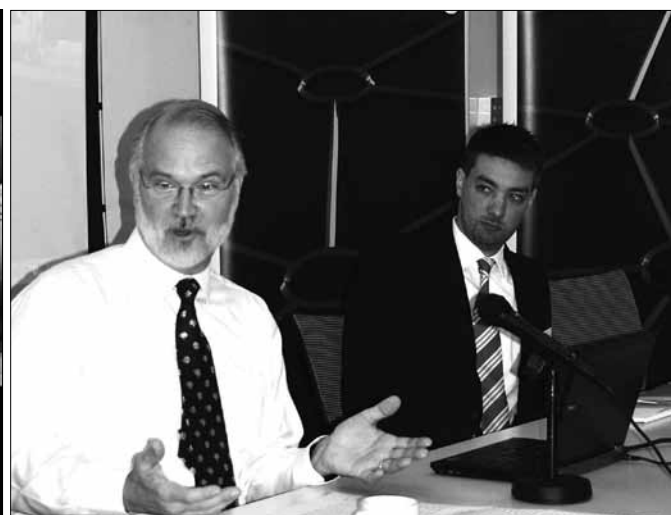
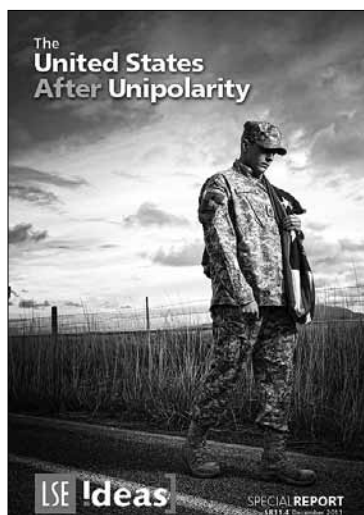
Formerly known as the Transatlantic Relations Programme, the United States International Affairs Programme was re-launched in May 2013. This change reflects the shifting strategic outlook in American foreign policy and will allow the programme to remain focused on the key questions driving contemporary foreign policy decision-making.

The USIA has 17 Research Associates, which are currently under review as the programme transition takes place. Past speakers at the programme's events have included: Madeleine Albright, David Trimble, John Ikenberry, Joseph Nye, Jim O'Neill, Arvind Subramanian, Jonathan Powell and Sir Hugh Orde.

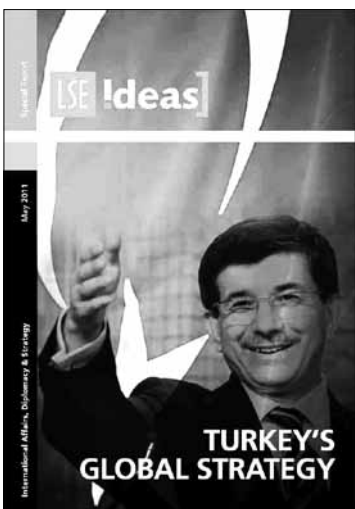

BRIEF SUMMARY

The **Middle East International Affairs Programme (MEIAP)** seeks to explicitly interact, from an academic perspective, with the major strategic issues facing the Middle East region over the medium term. At the moment these major issues include the aftermath of the Arab Spring, Iran's regional and international strategic ambitions, the evolution of Turkey's foreign policy, the future political trajectory of Iraq after regime change in 2003, and the final departure of US forces at the end of 2011. In order to achieve a deeper understanding of these topics, MEIA collaborates on an ongoing basis with LSE's newly established Middle East Centre. This partnership has proven very fruitful over the last two years, resulting in a very successful series of events co-organised and hosted by the two institutions.

Made possible by a private donation the Philippe Roman Chair is a one-year distinguished visiting professorship for leading scholars based outside the UK. The Philippe Roman Chair is awarded to a scholar and public intellectual of international repute, whose presence at the LSE will enhance the institutions standing in the competitive world of global higher education. In addition to conducting research and representing IDEAS and the LSE more broadly in public engagements, the Philippe Roman Chair teaches a unique postgraduate course of his/her design at the LSE.



TIMOTHY SNYDER

2013-14 PHILIPPE ROMAN CHAIR

Historian and award-winning author Professor Timothy Snyder will take up the Philippe Roman Chair in History and International Affairs for 2013-14.

Professor Snyder is currently the Bird White Housum Professor of History at Yale University, specialising in the political history of central and Eastern Europe as well as the Holocaust. A prolific author, he has written five award-winning books including *Bloodlands: Europe between Hitler and Stalin*, which has been awarded ten awards including the Emerson Prize in the Humanities and the Leipzig Award for European Understanding and was named on 12 book-of-the-year lists for 2010.

Professor Snyder said: 'I am delighted to be returning to the UK, where I earned my doctorate, and feel privileged to be joining colleagues whom I greatly admire at LSE.' Professor Arne Westad, director of LSE IDEAS, said: 'Tim Snyder has revolutionized our understanding of central and Eastern European history in the 20th century. It will be a privilege to have him teach here next year.'

Professor Snyder received his doctorate from the University of Oxford in 1997 where he was a British Marshall Scholar. He has held fellowships in Paris and Warsaw and Harvard, where he was an Academy Scholar, and is a frequent guest at the Institute for Human Sciences in Vienna. He regularly takes part in conferences on Holocaust education and is a member of the Committee on Conscience of the United States Holocaust Memorial Museum and sits on the advisory councils of the Yivo Institute for Jewish Research, the Association for Slavic, East European and Eurasian Studies. He is currently at work on two books, one a study of the Holocaust and the other a global history of Eastern Europe.

Professor Snyder will take up the post at LSE in October 2013 and will give four public lectures over the academic year on Eastern Europe and the World as well as conduct a postgraduate seminar series entitled 'The Holocaust as Global History'.

ANNE APPLEBAUM

2012-13 PHILIPPE ROMAN CHAIR

Author and Pulitzer Prize winner Anne Applebaum has taken up the post of Philippe Roman Chair in History and International Affairs at the School for 2012-13. She is the first woman to ever hold this position. Anne Applebaum is the Director of Political Studies at the Legatum Institute in London, and a columnist for the Washington Post and Slate. After graduating from Yale University, Anne

Applebaum was a Marshall Scholar at both the LSE and St. Antony's College Oxford. She has also lectured at Yale and Columbia Universities, amongst others.

Anne Applebaum's journalistic work focuses on US and international politics, with a particular focus on economic and political transition. Her career began in 1989 at The Economist, where she covered the collapse of communism as the Warsaw correspondent. In 1993 she became the Foreign Editor, and then the Deputy Editor, of the Spectator magazine in London, and has also held the position of Political Editor of the Evening Standard. She has written columns for numerous British newspapers throughout her career, including The Guardian, Daily and Sunday Telegraphs, before joining the Washington Post in 2001.

Her recent and best known book, *Gulag: A history*, won the 2004 Pulitzer Prize for non-fiction, as well as Britain's Duff-Cooper Prize. *Gulag: A history* has appeared in over two dozen translations, including all major European languages. Her first book *Between East and West: Across the Borderlands of Europe* awarded her the Adolph Bentinck Special Mention Award in 1996. In 2010 in Budapest, she received the Petöfi Prize for promotion of freedom and democracy in Central Europe.



RAMACHANDRA GUHA

2011-12 PHILIPPE ROMAN CHAIR

Ramachandra Guha is the Philippe Roman Chair in History and International Affairs for the 2011-2012 academic year. Ramachandra Guha is a historian and biographer. He has taught at the universities of Yale and Stanford, held the Arné Naess Chair at the University of Oslo, and been the Indo-American Community Visiting Professor at the University of California at Berkeley.

His books include a pioneering environmental history, *The Unquiet Woods* (University of California Press, 1989), and an award-winning social history of cricket, *A Corner of a Foreign Field* (Picador, 2002). *India after Gandhi* (Macmillan/Ecco Press, 2007) was chosen as a book of the year by the Economist, the Washington Post, the Wall Street Journal, the San Francisco Chronicle, Time Out, and Outlook, and as a book of the decade in the Times of India, the Times of London, and The Hindu. Guha's books and essays have been translated into more than twenty languages. The New York Times has referred to him as 'perhaps the best among India's non fiction writers'; Time Magazine has called him 'Indian democracy's preeminent chronicler'.

Ramachandra Guha's awards include the Leopold-Hidy Prize of the American Society of Environmental History, the Daily Telegraph/ Cricket Society prize, the Malcolm Adideshiah Award for excellence in social science research, the Ramnath Goenka Prize for excellence in journalism, and the R. K. Narayan Prize. In 2008, Prospect and Foreign Policy magazines nominated Guha as one of the world's one hundred most influential intellectuals. In 2009, he was awarded the Padma Bhushan, the Republic of India's third highest civilian honour.

NIALL FERGUSON

2010-11 PHILIPPE ROMAN CHAIR

Prof Ferguson of Harvard University is an academic historian, journalist and television presenter. He is Laurence A Tisch Professor of History at Harvard University, a contributing editor of the *Financial Times* and a senior research fellow at Jesus College, Oxford. He is also William Ziegler Professor of Business Administration at Harvard Business School and a senior fellow at the Hoover Institution, Stanford University. He has presented several television documentaries based on his books - the most recent being *The Ascent of Money* on Channel 4. After publishing *Colossus: The Rise and Fall of the American Empire* in 2004, *Time* magazine named him one of the hundred most influential people in the world.

GILLES KEPEL

2009-10 PHILIPPE ROMAN CHAIR

Prof Kepele of Sciences Po is best known for his books on the Middle East and North Africa, and for his work on Islamism, including *Islamism in Europe*. Professor Gilles Kepele holds degrees in Arabic, English and philosophy, a PhD in sociology and a PhD in political science. Previous international teaching experience includes a visiting professorship at New York University (1994) and a visiting professorship at Columbia University (1995-1996). He is Director of the Chaire Moyen-Orient/Méditerranée and of the doctoral program on the Muslim World at Sciences Po, and Director of the Middle East book series at the Presses Universitaires de France.

CHEN JIAN

2008-09 PHILIPPE ROMAN CHAIR

Prof Chen is the Michael J Zak Chair of the History of US China Relations at Cornell University, where he serves as Director of the China and Asian-Pacific Studies Program and is a distinguished research scholar, writer and teacher. Chen received his M.A. from Fudan University and East China Normal University in Shanghai and his Ph.D. from Southern Illinois University. He is a member of the editorial board for *The China Review* and *The Chinese Historical Review* and is Associate Editor of *The Journal of American-East Asian Relations*. He is author of *Mao's China and the Cold War* and *China's Road to the Korean War: the making of the Sino-American confrontation*, which is regarded as a modern classic, and shared honours for the 2005 Emmy Award for Outstanding Achievement in News and Documentary Research for *Declassified: Nixon in China*.

PAUL KENNEDY

2007-08 PHILIPPE ROMAN CHAIR

Prof Kennedy is currently the J Richardson Dilworth Professor of History at Yale University, where he teaches on political, economic, and strategic issues. He is one of the most well-known international historians working in the field today, and has reached a global audience through his books *The Rise and Fall of the Great Powers* (1987) and *Preparing for the Twenty-First Century* (1993). Kennedy is known for his writings on global politics, the influence of economics on grand strategies, and strategic issues. He is on the editorial board of numerous journals and writes for The New York Times and The Atlantic.

STRUCTURE

The year-long programme consists of 4 intensive weeks of lectures and seminars spread throughout the year; 2 weekend policy workshops and 20 evening seminars. A vast range of highly experienced and well known academics and policy makers from the LSE, other universities, think tanks, international organisations and government departments both in the UK and abroad keep the course intellectually stimulating, topical and highly relevant.

CONTENT

The programme begins by taking a fresh look at the nature of strategy, explaining why new approaches are needed and offering a rigorous assessment of the assumptions that underpin strategy. This is followed by modules analysing the changing nature of strategic trends and power shifts with regard to different regions and institutions. The next modules focus on the different types of risks and threats that may occur in the decades ahead. Finally, there are a series of exercises aimed to transform strategy into practice.
