
As your Head of Department, I am passionately committed to all of these aspects of our programme, as are all of our faculty and professional services staff.

#### A world centre for research and teaching

The Research Excellence Framework (REF) is a comprehensive evaluation of research quality across UK universities conducted by the Higher Education Funding Councils approximately every five to seven years. Findings from the 2021 REF reaffirmed LSE's status as a global leader in research, with the School consistently ranking at the forefront or near the summit in various assessments of research excellence.

#### The Department of Accounting

The Department of Accounting maintains its esteemed status as one of the foremost entities worldwide for both teaching and research in the economic, institutional, and organisational dimensions of accounting and financial management. Accounting at LSE is rooted in research and grounded in the social sciences, with a clear aim to influence accounting regulation, practice, or the professional realm.

Faculty members within the Department are actively engaged in research and education spanning a wide spectrum of accounting topics. They collaborate across disciplines such as economics, finance, history, law, management, organisational studies, psychology, and sociology. The Department's research and teaching endeavours encompass a broad range of subjects, addressing both private and public sector concerns and advocating for various evidentiary sources and investigative methodologies.

This year the LSE has been ranked first for Accounting and Finance by *The Guardian*, *The Times* and *The Sunday Times*. In the QS World Rankings 2024, the Department secures a prestigious position, ranking first in London, and sixth globally for Accounting and Finance.

## INTERVIEW WITH LSE ALUM OMIROS OMIROU

## BSc Accounting and Finance Class of 2019

Omiros, a native of Nicosia, Cyprus, completed his studies in the summer of 2019. He began his career journey at Goldman Sachs, initially as an audit associate before transitioning to his current role as their Global Market Analyst.

"Joining the LSE was a natural choice for me as it is an institution of unrivalled academic excellence. Its reputation ranks it among the top universities in the world, especially for courses like Accounting and Finance, which made me confident that I would receive the highest quality education and experience what it feels like to be studying with some of the brightest individuals of my generation.

Attaining a degree from such a prestigious institution opened doors for me to pursue my future aspirations. As for my degree selection, the decision was based on my desire to broaden my knowledge on two fields that I didn't get the chance to explore prior to attending the LSE and which I have always found interesting.

The thing that I love most about this programme is that it provides you with the necessary skills and knowledge to be able to understand concepts that you come across in your everyday life and puts you in a position to form an opinion and engage in constructive discussions on these. Alongside my university studies, I have mentored young minds at a professional, academic and personal level as a Career Mentor for the LSESU Investment Society, a Student Academic Mentor for the Department of Accounting and the Vice President of the LSESU Cypriot Society."

#### Why accounting and finance?

These were two fields that I didn't get the chance to explore prior to attending the LSE and which I have always had an interest in. Admittedly, it was a bit of a gamble for me to choose this but fortunately it paid off greatly!



#### What did you most enjoy about the BSc?

I mostly enjoyed the chance to work with a diverse pool of like-minded, talented and extremely motivated individuals, while broadening my knowledge on subjects that interest me. Looking back, I am positively surprised by the immense personal and professional development I have been through over the 3 years I was there. Getting hands on real-life applications enabled me to gain a deeper understanding of concepts that I come across in my everyday life and put me in a position to form an opinion and engage in constructive discussions on these.

#### Top society to join?

Definitely an Athletics Union (AU) society! Joining the Futsal society was one of the best decisions I've made during my time at the LSE. I got to meet a lot of people outside of my course and built genuine relationships with my teammates both on and off the pitch. The best part so far has been our trip to Prague to participate as a mixed team representing the LSE at a tournament there. It was a great chance to bond with each other and create memories that will last for a lifetime.

#### What have you enjoyed about living in London?

I found the fast paced style of living very enjoyable as it has given me an extra push to be efficient and productive at all times. Also, the fact that the list of museums, galleries, concerts, musicals restaurants and bars that you can visit is literally endless. I have never been bored because I can always experience something new!

## What is your top tips for students thinking about doing the BSc AF at LSE?

Just go for it! My journey over the 3 years while completing my BSc in Accounting and Finance at the LSE has been the most productive and rewarding journey of my life so far. ## Accounting Peer Mentoring Scheme

The accounting peer mentoring scheme is a student-to-student mentoring programme run by the Department of Accounting and LSE Life. As first year UG you will be matched with current second/third year accounting Student Academic Mentor (SAM). Your mentor will support you to make the most of LSE, sign post you to the right support resource and help you settle into the School.

#### **Academic Mentor**

Your Academic Mentor oversees your academic journey, ensuring progress and offering support in addressing any challenges, whether academic or personal. At the beginning of the Autumn, all undergraduate students will be allocated an Academic Mentor. Do not hesitate to reach out to your Academic Mentor whenever you encounter uncertainty or difficulty.

#### **AC10x Peer Tutor**

The AC10x Peer Tutor scheme run by the LSESU Accounting Society starts from week 3 of Autumn Term to the end of Winter Term. Peer Tutors are current second year Accounting student volunteers who are here to help you with your independent study of AC10x. Sessions are 1:1 every Wednesday at LSE Life.

#### Course choice video

#### **Accounting study space**
