Chris Alden is Professor of International Relations at the London School of Economics and Political Science (LSE) and is Director of LSE IDEAS. He is a Research Associate with the South African Institute of International Affairs (SAIIA).

He is author/co-author of numerous books, including: Apartheid's Last Stand - the Rise and Fall of the South African Security State (Palgrave 1996); Mozambigue and the Construction of the New African State (Palgrave 2003); South Africa's Post-Apartheid Foreign Policy (Adelphi Paper IISS 2003); China in Africa (Zed 2007); Land, Liberation and Compromise in Southern Africa (Palgrave/Macmillan 2009); The South and World Politics (Palgrave 2010); Foreign Policy Analysis - New Approaches 2nd edition (Routledge 2017); and co-editor of China and Mozambique: from Comrades to Capitalist (Johannesburg: Jacana 2014); China Returns to Africa (Hurst 2008); China and Africa - Building Peace and Security Cooperation on the Continent (Palgrave 2017); New Directions in Africa-China Studies (Routledge 2019) as well as having written numerous articles in internationally recognised journals.

Professor Alden has held fellowships at Cambridge University, Institute of Social Science, University of Tokyo; Ritsumeikan University, Kyoto; Ecole Normale Superieure (Cachan), Paris; CERI, Paris; and University of Pretoria.

Mr Maclay is Advisory Board Chairman on the British American Project and Steering Group Chairman, Franco-German-UK Club of Three. He is a former Chairman, Citizenship Foundation (2001-2014).

Tan Sri Dr Munir Majid is Visiting Senior Fellow at LSE IDEAS and his work is focused on ASEAN (Association of Southeast Asian Nations) regional politics and economy. Pre-pandemic, the Raitu Forum hosted a series of in person workshops in Turda, Romania. Even though our events and conferences went online this year, we received a record attendance to our 2020 Visions series.

OVERVIEW

The Central and South-East Europe Programme (CSEEP) at LSE IDEAS organises events, publications and collaborations with partners from Central and South-East Europe in order to generate a richer understanding of the region's history, geopolitics and current affairs.

CSEEP works closely with the Ratiu Forum, which supports researchers who focus on Romania and the wider region of Central and South-East Europe. Scholars receive funding in order to conduct their research and spend time in London and Transylvania. The Forum also facilitates CSEEP conferences, workshops and other events, with the support of the Ratiu Family Charitable Foundation.

PARTNERSHIPS

TCSEEP has two regional desks, based in Krakow (Poland) and Clui-Napoca (Romania), where we organise annual academic conferences, as well as Visiting Fellowships. The desks creating an extensive scholarly network in political sciences, sociology, history and international relations.

The partnership with Jagiellonian University, Krakow, was established in February 2020 and this year the collaboration has proved highly productive. Jagiellonian scholars have contributed to many CSEEP activities including public events, special reports and the Ratiu Forum blog. Later in 2021 we will welcome our first Jagiellonian Visiting Fellow.

EVENTS

CSEEP has maintained a strong events programme throughout 2020/21. This includes the ongoing discussion series, '20:20 Visions: Conversations on the Future of Democracy', and the events associated with the Ratiu Forum Journalism and Teaching of History programmes. CSEEP also arranged several stand-alone events in 2020, such as a special discussion on the Romanianborn British scholar of international relations, David Mitrany.

CSEEP event highlights include:

- 'The Ion Ratiu Dialogues on Democracy': a three-day series of online talks exploring challenges to liberal democracy in both the Central and South-East Europe region and globally.
- Tailored workshops for Romanian journalists and history teachers, exploring both theoretical and practical challenges to their professions and the importance of their work in sustaining liberal democracy in the region.
- November 2020 saw our special event, 'The EU and the Romani People', which focused on anti-Romani racism across the EU and featured special guest speakers Romeo Franz MEP and Dr Angela Kocze (CEU).

- The Ratiu Forum '20:20 Visions: Conversations on the Future of Democracy' series held monthly talks over 2020/21. Highlights included:
 - 'Europe's Frozen Conflicts: Kosovo, Transnistria and Eastern Ukraine' with James Sherr, Prof Mary Kaldor, Dr Cristina Gherasimov and Dr Julia Himmrich'.
 - The Impact of the US Presidential Election on Central and South-Eastern European Security and Defence' with Ivan Vejvoda, Corina Rebegea and Dr Wojciech Michnik.
 - 17+1: China's foreign policy in the Central and South-East European Region with Professor Michael Cox, Dr Yu Jie, Dr Ivana Karaskova, Edward Lucas,

PUBLICATIONS

CSEEP published its annual Cluj-Napoca Desk Report, 'Trianon: 100 Years After' early in 2021, drawn from the two-day online conference held on the 100th anniversary of the Treaty of Trianon, and features content by academics from Babes-Bolyai University, LSE, and UCL.

In March 2021 CSEEP published a special report, 'A Sea Change? The Impact of the US Presidential Election on Central and South-Eastern European Security and Defence' by Ivan Vejvoda, Corina Rebegea and Wojciech Michnik. It assesses the likely impact of the new Biden administration on security and defence in the Black Sea, Balkan and Central European regions.

CHINA FORESIGHT

Protect, Constrain, Contest: Approaches for coordinated transatlantic economic and technological competition with China

OVERVIEW

China Foresight continues to engage with the domestic drivers and global implications of Chinese foreign policy and strategy. The COVID-19 pandemic has once more proven the importance of far-sighted research on China's steadily evolving global role. Over the last year, the programme has consequently explored a wide range of topics, including economic and technological competition, and Beijing's changing posture in several regions around the globe. The programme has also welcomed a new Project Coordinator, Lukas Fiala, in March 2021 to lead the project following his predecessor Gidon Gautel's transition out of the role.

EVENTS AND PUBLICATIONS

In October 2020, China Foresight hosted a panel discussion on the nature of bilateral competition between the US and China, critically assessing whether this "new normal" represents a "new cold war". The discussion was complemented by another event in November analysing the implications of US-China competition for the rest of Asia. March 2021 saw the programme explore the historical foundation and evolution of China-Korea relations as well as the current state and future prospects of China's financial system. In collaboration with the Central and South-East Europe programme, China Foresight also co-hosted a panel discussion on China's 17+1 cooperation mechanism in Central and Eastern Europe in May.

The China Foresight Forum, consisting of the programme's affiliated China experts, remains a valuable source of expertise and advice. With the Forum's support, China Foresight organised two closed policy discussions on China's role in international standard setting and the UK's Taiwan policy in July 2020 and November 2020, respectively.

China Dialogues - the programme's opinion platform - has experienced significant growth in contributions and popularity since its inception in July 2020. Internal and external contributors wrote a total of 24 articles and expert commentaries on a host of different subjects, analysing China's technology policy, health diplomacy, military strategy, and policy vis-à-vis Hong Kong, among many others.

In January, the programme oversaw the publication of *Protect, Constrain, Contest: Approaches for coordinated transatlantic economic and technological competition.* The report provided far-sighted and actionable recommendations to UK policy-makers in the fields of trade and technology policy. Coinciding with the launch of China's space station core module Tianhe, China Foresight also published a Strategic Update written by Gidon Gautel on the risks of US-China competition in space.

CHINA FORESIGHT AND UIT

In May 2021, China Foresight initiated a year-long partnership with the Arctic University of Norway (UiT) which aims to explore China's engagement in the Arctic from the perspectives of the environment, security, and governance. The initiative is structured around three public seminars with leading experts from the region and private policy discussions among key stakeholders relevant to the UK's Arctic and China policies. The first public event took place in May and explored the implications of China's environmental policy vis-à-vis the region and the role that Chinese companies play in the mining of critical minerals.

OUTLOOK

Going forward, the programme aims to engage with new channels of communication to reach a broader audience, including the production of upcoming video blogs and a newsletter on China's engagement in the Global South, co-produced with the China and the Global South Project, formerly CAP.

COLD WAR STUDIES PROJECT

Despite the COVID-19 pandemic, the Project had another successful year, convening the LSE-Science Po Seminar in Contemporary International History (HY510) in cooperation with the Department of International History and launching a new LSE Cold War Podcast.

LSE-SCIENCES PO SEMINAR IN CONTEMPORARY INTER-NATIONAL HISTORY

Over the past three years, much work has been done to dramatically improve gender diversity in our annual line-up of speakers. In 2017/18 only 30% of speakers were female. In subsequent years the proportion of female speakers increased to 60% in 2018-19, 50% in 2019/20, and 50% in 2020/21.

We had an enthusiastic response to our calls for papers for the Michaelmas 2020 and Lent Term 2020 for HY510, in partnership with Professor Mario Del Pero at Sciences Po. Due to the COVID-19 pandemic we held all seminars on Zoom, chaired by Dr Alvandi and Dr Vesselin Dimitrov of the Department of Government. The logistics for the seminars were handled by our project assistant, Grant Golub.

GWU-LSE-UCSB GRADUATE COLD WAR CONFERENCE

The last Graduate Cold War Conference was hosted by the George Washington University in Washington, DC, from 2-4 May 2019. The next conference was due to be held at the University of California, Santa Barbara (UCSB), from 30 April to 2 May 2020 but was postponed until 2022 due to the continuing COVID-19 pandemic. LSE will next host the conference in 2023.

LSE COLD WAR PODCAST

Given our inability to host in-person events in 2020/21 and growing fatigue with online Zoom events in an already crowded LSE calendar, the CWSP opted instead to launch the new LSE Cold War Podcast, a regular podcast series featuring prominent historians who work in and around the field of Cold War History at LSE. Hosted by our project assistant, Jack Basu-Mellish, each episode features a scholar associated with LSE, covering their views on the field, how they became a Cold War scholar, as well as a deep dive into their current and past research. The primary audience for the podcast will be history students and other scholars in the fields of History and International Relations, highlighting LSE's place as a major global centre for studying the Cold War. Beyond this, we hope to attract listeners from the general public who are interested in Cold War history. Thus,

the interview style will aim to present academic questions in an easily digestible style for the informed non-expert.

The podcast is a collaborative effort between the CWSP and the LSE

Department of International History, who have generously provided funding for the purchase of the necessary equipment to produce the podcast in a high-quality audio format. The podcast is jointly promoted by IDEAS and the Department of International History.

To date, four episodes of the LSE Cold War Podcast have been produced and released, featuring Prof Arne Westad, Prof Kristina Spohr, Dr Roham Alvandi, and Dr Tanya Harmer, with more in the pipeline. In summary, despite the impact of the COVID-19 pandemic, the Cold War Studies Project remains vibrant, with an active program of research seminars and public engagement, ensuring that LSE retains its global reputation as the leading centre for studying the history of the Cold War.

CONFLICT RESEARCH PROGRAMME

OVERVIEW

The Conflict Research Programme (CRP) started their collaborative partnership with LSE IDEAS in September 2020 during the final year of its four-year flagship research programme. The Recognised Group focusses on policy and public impact through wide-reaching events, policy-focussed and academic publications, and ongoing engagement with local networks of researchers and civil society groups across field sites.

RESEARCH

The Conflict Research Programme (CRP) is a £6.7 million, four-year, FCDO funded research programme which started in March 2017. The goal across the programme has been to understand and analyse the nature of contemporary conflict and to identify international interventions that 'work', in the sense of reducing violence or contributing more broadly to the security of individuals and communities who experience conflict. The programme includes five research sites: Democratic Republic of Congo, Iraq, Somalia, South Sudan, and Syria. The research has two components:

- Examining the Evolution of Complex and Persistent Violent Conflicts

 CRP research focused on five countries in persistent violent conflict and analysed evolving incentives for peace and violence through three interrelated logics of war and peace: i) the political marketplace, ii) identity politics and iii) the role of public authority and local civic movements that provide social goods in times of conflict.
- What 'Works' to address Violent
 Conflict in Developing Countries?
 The CRP also developed evidence
 on the effectiveness of common
 responses to conflict, to better
 understand 'what works' and to test
 how interventions such as security
 sector and justice reform, subnational governance, and community
 level dialogue and mediation could
 reduce violence.

This year, the CRP has delivered a range of outputs including a second Conflict Zone podcast series, blogs, policy briefings and research papers and led on a collaborative online Silent Voices exhibition, highlighting the marginalised voices of global south researchers.

University, Justice Africa, Local Governance Administration Councils Unit (LACU), the Al-Bayan Center for Planning and Studies, Al-Amal Association, Public Aid Organization (PAO), Iraqi Women's Network (IWN) and the Institute of Regional and International Studies (IRIS) at the American University of Iraq, Sulimaniyah.

LEGITIMACY AND CITIZENSHIP IN THE ARAB WORLD

This project started in January 2019 with a 500.000 USD grant from Carnegie Corporation of New York. The support has been renewed in June 2021 with another 500.000 USD for two more years.

The project seeks to address two interlinked issues characterising the Arab world: a lack of democracy and persistent violent conflicts; two issues which remain despite the wave of public movements starting over ten years ago demanding change.

Scholarly debate on the reasons behind this has centred around a fixed set of issues – such as the rentier economy, ethno-sectarianism and geopolitics – and ignored the almost complete, centurylong exclusion of Arab citizens from the process of drafting constitutions and legislations governing their lives,

determining the shape and nature of their state. We aim to use our learnings to address the issue of the citizen's exclusion, its causes and its consequences in the Arab World through influencing the discourse on conflict resolution, citizenship, legitimacy and constitution-making through a combination of outputs: policy reports, media articles, roundtable discussions and public events.

VISIONS OF EUROPE

The aim of this project is to uncover and make visible visions of Europe among newly emerging movements and 'movement-parties' in civil society. The project involves pan-European mapping of the narratives of emerging movements and what we are calling 'Moments of Dialogue', including conferences, workshops and smaller discussions, and online communication. The geographical scope of the project includes European Union member states and their neighbourhood where significant movements are emerging. The project is carried out in partnership with Another Europe is Possible, European Alternatives, and the Institute for Human Sciences (IWM) in Vienna.

The main output of the project this year has been report mapping civil society visions of Europe from 2018-2020, titled The Rise of Insurgent Europeanism. Civil society in Europe and its attitudes towards the European project have changed dramatically in the past decade of multiple crises. The findings and recommendations of the report provide the basis for convening the Study Group on the Future of Europe, which strives to ensure that civil society voices and proposals can play a meaningful role in the ongoing Conference on the Future of Europe.

EVENTS

Online events have been an opportunity for the group's research to reach diverse audiences across the globe and have further engagement and impact amongst policymakers, academics and students interested in the research.

REPORT

After officially launching the Commission in 2019, the Commissioners issued their final report on 9 February 2021. The eighteen Commissioners heard from around 50 witnesses who covered a broad and diverse range of subjects. The final report issued ten actionable recommendations for the UK in order to set its foreign economic policy in a strategic manner suitable for the 21st-century world. It was pleasing to see Recommendation 3 on stress testing supply chains in the G7 communique.

EVENTS

There were two launch events – one in the UK on 9 February and a second US launch a week later, which was organised jointly with the Carnegie Endowment for International Peace. For both events, we were joined by prominent speakers - Lord Mark Sedwill. Chair of the G7 Panel on Economic Resilience and former National Security Adviser to PMs May and Johnson, and Dr Adam Marshall, Director-General of the British Chambers of Commerce, who spoke well of the report at the launch webinar. For the US event, we were joined by British Ambassador to the US Karen Pierce, alongside former World Bank President and ex-USTR Bob Zoellick and

a former Obama administration official. We also held several events to promote the seven Interim Reports, including a joint event at Chatham House at the midway point.


MEDIA PRESENCE

In terms of media and other dissemination, it is ongoing and includes op-eds in the *Financial Times*, an interview on the FT Rachman Review podcast, an article in the LSE in the World research magazine, among others. An up-to-date list can be found under 'Events and Activities' on the project website.

IMPACT

There continues to be significant interest from other policymakers, not just American but also EU officials. There have also been private meetings with policymakers and influential groups, including with the Department for International Trade (DIT), the Finnish Ambassador to the UK, and the Europe Group of TheCityUK, representing the financial services industry. Prof Yueh has also spoken at the virtual Forum on Economic Diplomacy in the post-COVID-19 Global Economy, with the support of the Diplomatic Academy of Peru.

In engagement with the UK government, we gave a Civil Service Trade Faculty Masterclass to over 200 civil servants, organised by DIT and the FCDO in May. Evidence was given at the International Relations and Defence Committee, House of Lords, and the G7 evidence session before the International Trade Committee, House of Commons. We have also made submissions to the UK Government's Integrated Review of Security, Defence, Foreign Policy and Development, as well as to the House of Commons Foreign Affairs Committee by invitation. We have been working with the Head of School's Public Affairs team on our dissemination and engagement activities. Finally, on the academic front, Prof Yueh is lecturing on economic diplomacy for our Executive MSc and moderated a panel on "From Economic Diplomacy to Economic Statecraft: A Return to Mercantilism in an Era of De-Globalisation?" at the high-level workshop of IDEAS and the Brussels School of Governance at the Vrije Universiteit. Prof Yueh has also lectured on the Commission's findings at the United Nations University

OVERVIEW

The Global Strategies project provides a forum for UK policy makers to access expertise at LSE, to contribute to enhancing the quality of decisions on issues relating to foreign, defence, and security policy.

During the year, the project has continued to benefit from the advice of former practitioners who are closely associated with LSE IDEAS. These include (with former roles): Peter Watkins (Director General Security Policy, Ministry of Defence); Professor Gordon Barrass (Chief of the Assessments Staff, Cabinet Office); General Sir Richard Barrons (Commander Joint Forces Command); General Sir James Everard (NATO DSACEUR); Sir Robert Cooper (senior advisor to the EU Commission); Michael Maclay, Chairman of the Franco-German-British leadership network, the Club of Three; Tom McKane (Director General International Security Policy, Ministry of Defence); Sir Richard Mottram (Permanent Secretary, Ministry of Defence); and Susan Scholefield (head of the UK's Civil Contingencies Secretariat).

ACTIVITIES

From January 2021, following a pause resulting from the pandemic, private round-table discussions were convened online with Whitehall policy makers and academic experts from LSE on issues covering climate change and national security, the renewal of democratic institutions, digital sovereignty, and China's economic and technological trajectory. These regular discussions, which have been conducted by the Global Strategies project since 2010, are based on an agenda of topics proposed by our Whitehall contacts.

In an initiative led by Peter Watkins, the Global Strategies project delivered papers on UK national security issues to senior members of the UK government, in advance of the Integrated Review, finally published in March 2021. This concluded with a public webinar on recommendations for the Review in October 2020.

A series of lectures has been organised on the theme of Strategy: New Voices, to reflect a new generation of strategic thinkers who are addressing contemporary challenges. The first lecture, on US national strategy, was held in June 2021, to be followed in the academic year 2021/22 by lectures on Russia's national strategy, on the strategies of Asian nongreat powers in response to China's rise,

on strategies for urbanisation in Africa, and on strategies of individual powers in combatting climate change.

The Global Strategies project has held the first of several planned discussions on NATO and the future of warfare, led by General Sir James Everard, Visiting Professor at LSE IDEAS, which will result in the publication of several Strategic Updates. These will provide advice and recommendations to policy makers ahead of the drafting in 2022 of NATO's next Strategic Concept.

In cooperation with the Club of Three, the Global Strategies project has helped to arrange three webinars during the first half of 2021 on Europe's role in contributing to security in the Indo-Pacific. A final webinar, and a Strategic Update on these discussions, will follow in the autumn of 2021.

IMPACT

The Global Strategies project provides a resource for UK policy makers working on foreign, defence and security policy. In Whitehall, the value of these conversations is evidenced by consistent support from relevant government departments. Within LSE, during 2020/21, the project has drawn on expertise from eight departments, institutes and research centres, making this knowledge available to decision makers and a wider public.

The LSE Global South Unit (GSU) and LSE IDEAS have continued their successful, collaborative partnership that began in the summer of 2017. Its focus has been on delivering joint events, combining resources to have a greater impact via teaching at LSE and abroad, and publishing literature of high academic and policy impact.

In Michaelmas Term 2020, Prof Christopher Alden and Dr Alvaro Mendez delivered at LSE the fifth edition of their annual successful undergraduate and postgraduate unit titled 'China and the Global South'. In LentTerm 2021, Prof Alden and Dr Mendez delivered at Sciences Po Paris the fourth edition of their annual course 'China's Diplomacy & the Global South'.

During 2020, the UN Business and Human Security Initiative reached the end of its first phase. In completing the first phase, the programme published the report 'Human Security Business Partnerships: A framework for collaborative action and innovation', a field manual on how to set up and implement partnerships, and a series of policy briefs including 'The Social Impact of Business in Business in Fragile and Conflict-Affected Settings'. In addition, the programme has launched a video series titled 'Local Voices', filmed in Colombia and Liberia, which illustrates the case for the HSBP Framework

The programme held multiple outreach events, including the conference 'Partnering with Business to Promote Human Security and the SDGs' and the roundtable event 'Engaging the Tech Industry for Building Peace and Human Security'. A contribution to the strategic review of the UK Foreign Office and the Department for International Development,

as well as media articles on sustainability, human security and the pandemic, have also provided further opportunities to raise awareness of the Framework.

The programme is currently working with global construction materials group Cemex to assess, refine and replicate their social investment programme in northern Mexico through applying a human security approach. The team continues to prepare a report to the UN Secretary General on improving private sector contributions to sustainable development and positive peace. In addition, the programme has launched a video series titled 'Local Voices', filmed in Colombia and Liberia, which illustrates the case for the HSBP Framework.

The final application for a second phase of the programme has been submitted to the UN Human Security Trust Fund. This phase will focus on increasing awareness and uptake of the Human

Security Business Partnership Framework, seeking to initiate the partnerships in diverse settings. The proposal for phase 2 includes a support facility for providing assistance to businesses, local communities and other stakeholders, in order to incorporate the human security approach and measure positive impacts on the SDGs. Another key feature will be training materials and activities, based on the HSBP Framework and the human security approach – for companies, investors, UN agencies, researchers and civil society organisations.

This past year has been unique and bewildering for everyone. No single event in the history of humanity has ever affected the entire world in the way the Covid-19 pandemic has done; never has contemporary connectivity and movement across the world been so completely paralysed. Even the Second World War did not paralyse the world quite as the COVID-19 pandemic has done.

The changes at the LSE South Asia Centre were equally dramatic and impacting. Our Administrator Tamara Williams moved laterally within LSE as Manager in the Estates Department in April 2020; the term of Dr Mukulika Banerjee as Director ended on 31 July 2020; and the Editor of the 'South Asia @ LSE' blog and our Events/Communications Officer Christopher Finnigan left LSE to join HM Treasury in September 2020. We thank them all for their time at, and

contributions to, the Centre, and wish them all good things in future. So, the Centre's sixth year (2020/21) started with just one full-time staff member, Deputy Director Dr Nilanjan Sarkar alongside the new Director, Prof Alnoor Bhimani, and a complete move of our activities online — and it has remained so a year on.

We used this dramatic context — both within and without — to carve new paths, introduce radical intellectual ideas, and fundamentally overhaul the profile of the Centre. Here are some highlights:

- A new tagline: 'Unravelling South Asia to the World'
- A fixed calendar of events at the start of each term
- All event recordings made available for future viewings on the Centre's You Tube channel
- Specially curated events leading to Working Papers
- Thematic series of events across the academic year, with internal and external collaborations
- Widest possible coverage of different countries of South Asia in our Events

The success of this strategy has been tremendous. We made the best use of our complete reliance online to convene events with participants spread across

time and space, and the strategic use of social media has increased the profile of the Centre exponentially; just Instagram alone has seen an increase of 300+ followers between September 2020 and July 2021. Social media and digital communications have seen a spike, a success for the strategic changes at the Centre in the last year. A streamlining of blogposts has allowed us to publish on a variety of themes, within the limitations of lack of staff.

WORKING WITH LSE IDEAS

The Centre is a Recognised Group located within LSE IDEAS. We made the best use of this association with a brand new, South Asia-focused event series titled 'Geopolitics beyond Borders', in collaboration with Professor Chris Alden (LSE IDEAS) and IISS, London. Three events through the year drew a huge global audience, and two Working Policy papers will be published form them. The events were:

■ The Dragon's Ring: China in South Asia (pictured) — A Roundtable on China's increasing influence in South Asia, with Filippo Boni (Open University UK), Li Li (Tsinghua University, Beijing), Rahul Roy-Chaudhury (IISS, London) and Nilanthi Samaranayake (CNA, Virginia). A Working Paper will be published online from this event.

- Different Stars, Different Stripes: The US in South Asia A Panel Discussion on how the election of President Biden would change US engagement in South Asia, with Husain Haqqani (Hudson Institute, New York), Daniel Markey (SAIS, Washington DC), and Rani D Mullen (William & Mary, Virginia). A Working Paper will be published from this event.
- Kashmir: Frontier or Shroud? Organised around a recent publication, this event discussed the vexed issue of Kashmir and India-Pakistan bilateral relations in the current climate. Speakers included Myra Macdonald (author of White as a Shroud: India, Pakistan and War on the Frontiers of Kashmir), Pallavi Raghavan (Ashoka University, Sonepat) and Farzana Shaikh (Chatham House, London).

The Centre also ran a special series titled Fabian Dialogues with Professor Michael Cox (LSE IDEAS) who is writing a new history of LSE, and the Fabian Society London on prominent Fabians who were involved in South Asia – Beatrice & Sidney Webb, Harold Laski (pictured), and Leonard Woolf. The series was especially important because of the several difficult questions it dealt with the Fabians' support of eugenics, for example, alongside the several positive contributions.

OTHER EVENT HIGHLIGHTS

The past year gave us the opportunity to celebrate Bangladesh in a special way — with the twin anniversaries of the birth centenary of Bangabandhu Sheikh Mujibur Rahman, Bangladesh's founding father, and the golden jubilee of her independence in 1971. Bangladesh remains unique in being the only country in the region to have fought for independence from another regional state (Pakistan). The Centre hosted a special lecture by Nobel Laureate Amartya Sen to mark 'Mujib100', and a series of events

and blogposts to commemorate 'Bangladesh @ 50' with a specially commissioned logo (pictured). Sen's lecture has been viewed more than 350,000 times.

Other events focused on the military coup in Myanmar, the presidential elections in Sri Lanka, the response to the COVID-19 pandemic across the region, UK-India trade relations after Brexit, minority rights in Pakistan, and so on. Several new themes were also explored in this year's events, enhancing the profile of the Centre as a platform for radical debates: these included conversations on racism amongst South Asians, menstruation and period poverty, the future of cryptocurrency in the region, women & start-ups, eugenics, populist history, and the decolonisation of knowledge. For the first time since the establishment of the Centre in 2015, we also had two events with participants from Bhutan.

Humanity lost a shining stalwart in the death of Ibn Abdur Rehman, Magsaysay-award winning human rights activist in Pakistan. The Centre had hosted Mr Rehman on the occasion of the international launch of the Asma Jahangir Foundation in 2018 and had carried an interview with him in our flagship 'South Asia @ LSE' blog in August 2018. We hosted a special 'In Memoriam' on 4 May 2021 to mark the passing of Mr Rehman, with lawyers and activists from Pakistan and India.

We have kept receiving applications for our Visiting Fellowships, we hope to have Visiting Researchers at the Centre in the next academic year. As we emerge slowly from the shackles of the pandemic, and look ahead to the next academic year, we hope that new events, activities and research-resource outputs will further strengthen the Centre's position as the best academic hub for South Asia in the United Kingdom.

DIGITAL IR IN THE INFORMATION AGE

The Digital IR in the Information Age (or Digital IR in short) project aims to identify trends and developments in the world of technology and examine their implications for international relations. Through publications, public events, and other modes of public engagement, the Digital IR project looks to be a bridge to bring about greater understanding of technology-related issues to policymakers and the wider public.

The project has pioneered the release of the 'Subject Primer' series, which are a set of informative documents intended to provide a clear and concise introduction to various topics pertaining to technology and IR.

Publications that have been released since the project's launch include:

- Subject Primer The Infrastructures of Global Connectivity: 5G Networks
- Strategic Update Twitter and Digital Diplomacy: China and COVID-19
- Strategic Update Making Sense of Technological Spheres of Influence
- Working Paper Social media's impact on political discourse in South Africa
- Book Review 2034: A Novel of the Next World War

Some of these publications have also been re-posted and mentioned in prominent blogs and platforms elsewhere.

Moving forward, the project will look to invite prominent subject matter experts and practitioners as speakers for events and conferences to provide insight into some of the most pressing policy-related tech issues (e.g., state-sponsored cyberattacks, misinformation campaigns). The project will also explore other modes of engagement, such as podcasts or pre-recorded/live Q&A sessions with experts.

Through such avenues, the Digital IR project looks to expand the LSE network in this subject area and position itself as an important avenue where vital cross-sector dialogue occurs.

WOMEN IN DIPLOMACY

In September 2021, a new project will launch at LSE IDEAS on the role of women in diplomacy.

International diplomacy has long been dominated by male voices. This is despite a proliferation of networks supporting women in diplomacy, purported support by numerous governments for increasing women's representation in all levels of decision-making, and research illustrating the benefits of including women in negotiations.

This programme seeks to bring female voices to the forefront, asking questions such as how can female leadership change the state of international affairs, what are the challenges to female leadership, and how can women's participation in diplomacy be strengthened?

Primarily the project will take shape through a series of events. The launch event, due to be held in October, will explore the role of women in diplomacy in the 21st century. In this event, panellists will be asked to consider the extent to which the context has changed over the course of their careers and the work that remains to be done to improve women's representation in diplomacy.

The project will also establish a women's network based at LSE IDEAS bringing together diplomats at all levels of their careers both in the UK and abroad.

OVERVIEW

IDEAS Europe is a new programme at LSE IDEAS, with the aim of focusing on how continuing global power shifts are likely to impact Europe and the European Union. Its principal remit is to study the changing relationship between Europe and the United States, and the challenges posed by China, Russia and Turkey. Special attention is also given to the evolving relationship between the EU and the UK in the fields of security and foreign policy. The programme is designed to build upon the work achieved by the Dahrendorf Forum.

PARTNERSHIPS

IDEAS Europe has formed partnerships with other leading institutions across the continent. This includes partnering with the Brussels School of Governance, at Vrije Universiteit Brussel, to format a highlevel two-day conference, concerning 'A New Diplomacy for the Emerging Global Binary'. Similarly, we have also engaged in a partnership with the Friedrich Naumann Foundation, a think tank based in Germany which offers political education throughout the country and abroad. Along with the Foundation, IDEAS Europe has run a closed-door roundtable discussion with leading EU strategic thinkers, with the aim of producing reports on the future of EU "Strategic Autonomy".

EVENTS

On Thursday 27 May, IDEAS Europe hosted an invite-only roundtable workshop to discuss the 'Strategic Autonomy of the European Union'. This was attended by leading thinkers, academics and policy makers in the modern European space and, though conducted under Chatham House rules, will provide the basis for the production of reports concerning both internal and external threats, as well as opportunities for EU autonomy in the military and diplomatic realm.

On Thursday 17 and Friday 18 June, IDEAS Europe hosted a high-level conference in partnership with the Brussels School of Governance, called 'A New Diplomacy for the Emerging Global Binary: Digitalisation, Pandemics and the Search for a Reset'. This is a timely debate about the future of diplomacy in the contemporary global binary era and across the two-days has speakers including: Dame Judith MacGregor, Professor Karen Smith, Sir Peter Westmacott, Professor Amitav Acharya, Clare Wenham, Kishore Mahbubani, Simon Evenett, Kho Chung, Gideon Rachman and more.

PUBLICATIONS

Hedging by Default: The Limits of EU "Strategic Autonomy" in a Binary World Order.

Richard Higgott and Simon Reich explore how the EU now appears to have embarked on a hedging strategy in an increasingly bifurcated world.

We are also publishing a report from the Workshop we held alongside the FNF, 'Expert Roundtable on Strategic Autonomy'.

Finally, in late July 2021, Richard Higgott and Giulia Tercovich wrote up their rapporteur notes from our 'New Diplomacy' conference, which will be published in collaboration with LSE IDEAS.

FELLOWSHIPS

2021 MLADENA AND DIANKO SOTIROV VISITING FELLOWSHIP

LSE IDEAS is pleased to host the Mladena and Dianko Sotirov Visiting Fellowship thanks to the generous endowment by Mrs Mladena Sotirov.

Sotirov Fellows study Bulgaria and the Balkan region, working to understand its recent history, international affairs, the challenges it faces today and the prospects of tomorrow.

The Visiting Fellowship covers a one to two-month research stay in London any time between June and September each year.

It is intended primarily, but not exclusively for scholars in the early stages of their career, namely doctoral candidates and post-doctoral fellows whose work and research focuses primarily on a topic related to the history of international affairs of Bulgaria and the Balkans in the twentieth century. Exceptionally, research of distinct quality focused on current issues may also be taken into consideration.

JINNAH FELLOWSHIP

LSE IDEAS is pleased to announce the Jinnah Postdoctoral Fellowship which is open to Pakistani scholars who would like to study any aspect of Pakistan's foreign and security policy. The goal of the Fellowship is to spark meaningful conversations about Pakistan and its place in the world. It has been generously funded by Dr Saqib Qureshi, the Canadian Jaffari Muslim Foundation and other donors.

For the academic year 2020/21, the scholar was based in Pakistan. In future years we hope the scholar will be based in London at the LSE IDEAS office.

The Fellowship was for 3 months (January to April). At the end of that time, the Fellow produced a scholarly paper for publication and delivered an online lecture.

STONEX PHD SCHOLARSHIP

(LSE IDEAS and Department of International Relations)

LSE IDEAS is announcing a new PhD Scholarship to begin in September 2021, funded by a generous donation from Mr Cato Stonex (LSE BSc International Relations 1986). The deadline for application was 14 January 2021.

Proposed PhD topics may cover any aspect of the following research areas:

- China Foreign Policy and Security
- Digital Diplomacy

Applicants are required to possess a master's degree in International Relations with distinction in the dissertation. The successful candidate will undertake a four-year programme at the International Relations Department and will be contributing 7-10 hours per week to the work of LSE IDEAS, LSE's foreign policy think tank.

This scholarship is for citizens or residents of the UK. International applicants are not eligible to apply for this scholarship. The scholarship will be awarded on the basis of academic merit and the research proposal submitted.

The scholarship is a fixed amount per year, for a total of four years. It covers the tuition fees and a living costs stipend for a UK PhD student.

ENGELSBERG CHAIR IN HISTORY AND INTERNATIONAL AFFAIRS

LSE IDEAS is proud to host the Engelsberg Chair in History and International Affairs for the second consecutive year, made possible with funding from the Axel and Margaret Johnson Ax:son Johnson Foundation. The Engelsberg Chair is an annual distinguished visiting professorship for leading and global scholars who will give public lectures on topics of their choice. The Chair's presence provides IDEAS with the opportunity to bring a year of research and discussion to the wider LSE from a renowned academic.

The 2020/21 academic year has seen the return to LSE IDEAS of its co-founder, Professor Odd Arne Westad, as the second Engelsberg Chair. Prof Westad is a scholar of modern international and global history, with a specialization in the history of eastern Asia since the 18th century, currently the Elihu Professor of History and Global Affairs at Yale and is a former director of LSE IDEAS. The author of sixteen books, today Westad is mainly interested in researching histories of empire and imperialism, first and foremost in Asia, but also world-wide. He is also trying to figure out how China's late twentieth century economic reforms came into being and how their results changed the global economy.

This year's lectures were themed 'Empires Past and Present', exploring the concept of empire and why it is still relevant today. The first lecture, in November 2020, dealt with the ideas of empire and resistance to empire in a long historical perspective. The second lecture, in January 2021, provided a snapshot of what the world looked like in 1800 and the persistence of some key themes from that age for our world today. The third lecture, in March 2021, observed changes and challenges of empires around 1900 and how these transformations created the modern world. The final lecture in June 2021 concluded with 'Empires Today', questioning power-shifts away from the inheritance of empire and towards new forms of international interaction.

The Engelsberg lectures proved a popular success, especially so given the current necessity of exclusively online lectures and podcasts due to the global COVID-19 pandemic, receiving some of the highest audience figures at IDEAS events this year. The lectures were consistently rated 'Excellent' in event feedback and drew in a large proportion of academics and LSE students (both current and alumni); those identifying as female made up a large majority of the audience, and just under 50% of audience members were first time attendees of an LSE event.

In addition, Prof Westad took part in a panel discussion, titled 'US-China Great Power Competition: a new cold war?', in October 2020 and in a workshop titled 'Influence of Choice: Alternative histories of non-hegemonic foreign policy in the Cold War', on 3-4 December 2020. In March 2021, Prof Westad collaborated with the China Foresight programme at IDEAS, discussing the subject of his recent book, Empire and Righteous Nation: Past, present and future of Sino-Korean relations (2021), alongside Prof Rosemary Foot and Dr James Hoare.

The 2021/22 academic year will see acclaimed historian Professor Margaret MacMillan join IDEAS as the third Engelsberg Chair, delivering a lecture series on the nature, dynamics and types of alliance systems in war.

SUMMARY


Since its inception in 2011. the Executive Masters Programme has attracted the highest calibre of professionals in diplomacy and international affairs, defence, international business, and finance. The programme is tailored for those who operate in high pressure environments and with little time to spare. With its tenth intake of students graduating in December 2021, the Executive MSc in International Strategy and Diplomacy has quickly gained a reputation as one of the leading courses in strategic thinking in the world.

STUDENTS

The thirty-three students admitted in 2020/21 come from both the public and the private sector. This balance is most important in stimulating group discussion with a variety of views and perspectives. The group of past and current students covers a wide range of professions and sectors including international affairs, defence, finance, international business, and NGOs. See below for a breakdown of previous and current participants' backgrounds.

CONTENT

The programme begins by taking a fresh look at the nature of strategy, explaining why new approaches are needed and offering a rigorous assessment of the assumptions that underpin strategy. This is followed by modules analysing the changing nature of strategic trends and 'power shifts' with regard to different regions and institutions. The next modules focus on the different types of risks and threats that may occur in the decades ahead. Finally, there is a series of exercises aimed to transform strategy into practice.

STRUCTURE

Through interactive seminars and workshops, participants will engage directly with both senior academics and practitioners.

The year-long programme consists of:

- Four intensive weeks of lectures and seminars spread throughout the year
- Two policy workshop weekends
- Twenty evening lectures and seminars.

This year, the Programme effectively adapted its delivery in response to the COVID-19 pandemic. Between September and November 2020, the sessions were delivered in hybrid format, meaning that students residing in the UK attended sessions in-person on campus, whilst those unable to travel to the UK actively participated in the same sessions remotely. UK national lockdowns forced the Programme to switch to a fully online delivery from the Second Intensive Week in December onwards. Both types of delivery were well received by students and faculty.

FACULTY

A vast range of highly experienced and well known academics and policymakers from the LSE, other universities, think tanks, international organisations and government departments both in the UK and abroad keep the course intellectually stimulating, topical and highly relevant.

ALUMNI

Upon graduation from the Executive Programme, students join the LSE IDEAS Alumni Network. LSE IDEAS Alumni become a part of a constantly growing and diverse global network of leaders, professionals and experts as well as the dynamic LSE IDEAS community. With over 300 professionals, the Alumni Network is increasingly active with continued initiatives to share, connect, and engage in discussions surrounding international strategy, diplomacy and current affairs. With unique insight into LSE IDEAS activities, Alumni are key to the life of the Centre, participating in public and exclusive events, delivering their expertise, and composing cutting-edge strategic updates. Over the past year we held a series of student and Alumni meetings, public lectures and social events - all of which concluded in success and incited further expansion of Alumni activities going forward.

The "Meet the Leader" event series continued throughout the year, as leading practitioners of strategy and diplomacy engaged in fireside chats with Alums and the current student cohort. Most recently, we hosted Naheed Nenshi, the 36th Mayor of Calgary, Canada, and Ailish Campbell, Ambassador Designate of Canada to the European Union.

The Alumni Network Organisational Committee has successfully undergone a handover to the class of 2020. The committee has worked closely with the LSE IDEAS Alumni Network Manager to organise the Alumni Policy Weekend and coordinate further online networking initiatives.

The Alumni Policy Weekend was once again hosted in virtual form, with LSE IDEAS Faculty and distinguished guests joining the Alumni

on Saturday 5th June. The event connected Alumni across the world, facilitated a discussion with LSE IDEAS experts and gave the opportunity to further develop and strengthen the network.

We continuously connect Alumni from relevant sectors to consult prospective students and act as LSE IDEAS Ambassadors for future cohorts of the MSc International Strategy and Diplomacy Programme to come. We are also working on keeping the database up-to-date and exclusively accessible amongst the network, unlocking its potential to discuss, debate, connect, collaborate and support.

LSE IDEAS Alumni are also a part of a private LinkedIn group: Executive MSc in International Strategy and Diplomacy @ LSE IDEAS, which acts as a platform for Alumni to stay in touch.

WEBSITE PAGEVIEWS (1st August 2020— 31st July 2021). The 2020/21 academic year has been fully online and allowed us to continue focussing our digital activities. We have seen growth in engagement and following across all platforms. We continued hosting events online using both the Zoom platform and Facebook. Alongside this, we made both audio and video recordings available of events for people who were unable to attend webinars. We are also using our YouTube channel to host project videos, including interviews and Exec MSc alumni events.

The LSE IDEAS website is regularly updated, including the home page, to ensure the latest events, podcasts, publications, and news are readily accessible to users. New project webpages are in the works, including Digital IR in the Information Age, IDEAS Europe, and Women in Diplomacy. Work is ongoing with all research projects to ensure their webpages are up to date with activities and content.

We work closely with LSE's central Media Relations and Public Affairs teams to promote the work of LSE IDEAS, including ongoing work based off the recommendations of the LSE Economic Diplomacy Commission, and findings from a recent China Foresight report. We also have frequent communication with BlueSky PR for both reactive and proactive content involving LSE IDEAS people.

China Foresight Forum launched the 'China Dialogues' blog on the LSE Blogs platform in August 2020. There have been twenty-nine blog posts so far, amassing a cumulative 18,000 views. The China Foresight webpage has been updated and restructured to better incorporate the China Foresight Forum.

The Cold War Studies Project launched a fortnightly podcast which is available on the main podcast hosting platforms. It is also featured on the LSE IDEAS website. The podcast is promoted on a regular basis across social media in collaboration with the communications team at the Department of International History to ensure the broadest reach.



COLD WAR HISTORY

Founded in 2000, Cold War History is recognised as the leading journal in its field. Its purpose has always been to help shape the historiography of the Cold War by publishing articles and historiographical reviews by leading scholars and emerging talents from across the world in all areas of historical relevance.
