I am a member of the Operational Research Society. In 1973-4 I was a member of its National Events Committee; and I was a member of the programme committee for the Operational Research Society Annual Conference for 1977, and for the EURO Summer Institute held at the University of Canterbury in 1986. I act as a consultant on planning problems, with a concentration on the planning of health services, and was an advisor to the All Party Parliamentary Group on AIDS from 1990-3. During 1990-1 I was a member of the Home Office Working Group on The Partnership in Crime Prevention, and a signatory of its report "Safer Communities". I was Advisor to the Ministry of Planning and Development of the Government of Venezuela in 2000-7, and to the Ministry of Finance and Planning in 2010.

I have read papers at international conferences since 1965, including plenary or semiplenary addresses at a number of international conferences including IFORS XII (Athens 1990), CLAIO 7 (Santiago 1994) and EURO XIII (Glasgow 1994). I have given plenary addresses to the national operational research society conferences of SORA (Stockholm 1989), ORSSA (Johannesburg 1995), APDIO, (Lisbon 1996) AIRO (Perugia 1996) and INFORMS (Atlanta 1996). I was an Editorial Associate for the European Journal of Operational Research from 1981 to 1984. I am currently a member of the Editorial Board of Omega, and of Health Care Management Science. In 1990 and 1993 I was a member of the jury for the IFORS Third World Prize, and in 1996 was Chair of the jury of the renamed Operational Research in Development Prize. In 1992 I was joint chair of ICORD '92 (International Conference on OR for Development) in Ahmedabad; and in 2005 I co-chaired ICORD V at Jamshedpur. In 2006 I was a jury member for EURO's Management Science Strategic Innovation Prize. I am on the Editorial Board of the International Journal of Strategic Decision Sciences.

In 1966 I was a Labour Parliamentary candidate. During 1971-2 I was Chair of the British Society for Social Responsibility in Science, and have been Secretary of the British Committee for the Universities of Palestine since 2008. I have published extensively on

issues of Science and Society. I am a Trustee of the Science and Society Trust, and of the Human Nature Trust.
