

# Dean's Introduction

The LSE aims to be the "world-leading social science institution with the greatest global impact". The mission and vision of the School of Public Policy are analogous: to be a world-leading public policy school with a global outlook and the most significant impact on policy. Our goal is to train the best policy analysts—those who can understand the causes of things—and also the best policy and political leaders who can direct, engage and persuade for the betterment of society.

This summer, the School of Public Policy turns five. We have now spent half a decade working to deliver on those aims. This birthday is a good moment for stocktaking. Here are a few things that have changed since we launched the School in the Summer of 2018.

Back then, we inherited one full-time master's programme, and today, we run three, including the new Data Science and Public Policy programme that starts in August 2023. We had no double degrees, and today we have three —with Columbia University in New York, Sciences Po in Paris and the Munk School at the University of Toronto. The result is that we have gone from 70 full-time students to 350. And 57% of them are women!

The School of Public Policy has always been international, and now, we are more diverse than ever, with students from nearly 50 countries and a greater presence from regions that were under-represented in the past, including Africa, Central America and Central Asia. Plus, one in ten students now receives scholarship support from the SPP.

Five years ago, we had almost none of our own faculty. Today we have three Full Professors, five Professors of Practice, two Associate Professors (Education), one Assistant Professor (Education), and a host of LSE Fellows, Policy Officers and Policy Fellows. Plus, we continue to draw on the teaching talent of departments around the LSE.

We pursue education for impact - our students go on to policy and political responsibility positions at the local, national and international levels. And our faculty's policy-oriented research helps governments navigate the many challenges of today.

Perhaps most important of all, there is excitement and energy in the SPP. I saw it in the graduations and I see it every day in our facilities.

All LSE students value the credentials they get. I would like to think SPP students also have a good time while obtaining them! Routinely, I ask SPP students

to tell me the best things about our programmes and where we can improve. The one positive feature that gets the most mentions is the extraordinary diversity of our cohorts. Our students learn from our excellent teachers and learn from one another - from a classmate who came from a different continent, spoke a foreign language and grew up in a different culture. In that way, memorable late-in-the-evening conversations and lasting friendships are nurtured. I cannot imagine a more welcome development in a world often divided by prejudice and toxic identity politics.

I shared two brief parting thoughts in my remarks to our 2023 graduates. The first one was: never give up hope. Yes, the world faces plenty of pressing concerns, but the current fashion for pessimism is a pandemic. If, at an academic or social event, one does not moan that things are getting worse every day, one risks not being taken seriously.

My advice was: have no such fear. Over the last hundred years, life on Planet Earth has improved massively. And if we do things right, it will continue to improve. As the German-American political theorist, Susan Neiman wrote recently,

If we succumb to the seduction of pessimism, the world as we know it is lost... Whether you see the proverbial glass as half-full or half-empty is more than a matter of temperament. If you cannot see it as half-full, you will eventually stop trying to fill it.

And here is the second thing I suggested to the graduates: do not be too sure of what you have learnt. The complete certainty of diatribes in Twitter and the political arena nowadays also amounts to a pandemic. The philosopher Isaiah Berlin famously distinguished between hedgehogs, who know one big thing, and foxes, who know many things, but do not pretend to be sure about any of them. I hope SPP graduates will be like Berlin's foxes and always leave a little room for doubt.

I am confident that SPP students, faculty and professional staff can be proud of what we accomplished together in 2022-23 and over the last five years. I look forward to continuing to work shoulder-to-shoulder with the members of this extraordinary community.



## In The Policy Arena



**Andrés Velasco** 

Professor Andrés Velasco joined a World Bank-convened advisory group on "Drivers of Economic Growth" in South Africa. The group, which also includes Nobel Prize laureate Michael Spence and Montek Singh Ahluwalia, the former Chair of the Planning Commission in India, will consult with the Government of South Africa on its development strategy.

Professor Andrés Velasco also lead the Co-Lab team, along with Dr. Chris Canavan and Co-Lab researchers Sheyla Enciso and Camila Arroyo, to carry out growth diagnostic exercises for the Government of Mozambique. The team paid its first visit to Maputo and met with leading government officials in June 2023.

He also published an essay in the prestigious journal Foreign Affairs entitled "<u>The Change Chileans Really Want</u>". Professor Velasco argues that voters were right to reject the proposed constitution for Chile in September 2022.

In July 2023, Alexander Evans was appointed a Trustee of the International Longevity Centre and a member of the Advisory Council of Wilton Park. He continues to serve on the Advisory Council of the British Library. He participated in the Ditchley Foundation conference on China and the World: the impact of Russia's Ukrainian Tragedy (New York, September 2022) and is a member of the Ditchley Science and Technology Group. He chaired part of Democracy in the Age of Putin (Romania, September 22) and was invited by German MPs to speak on their forthcoming national security strategy (Berlin, October 2022). In February 2023 he was invited to speak on Asian security during bilateral talks between Pakistan's Chief of Army Staff, General Asim Munir, and General Sir Patrick Saunders, the UK's Chief of the General Staff. In April 2023 he met with UN officials on technology, non-proliferation and sanctions in New York. He has led sessions on strategy for the UK Cabinet Office and the Office for the Secretary of State for Scotland and taught masterclasses on foreign policy for the FCDO International Academy. He has also met with visiting official delegations including from Kenya, India and Estonia.

Over the last academic year, SPP Fellow Omar Hammoud-Gallego has published a research article on the American Political Science Review, the foremost journal in political science worldwide and an academic book review. He has been invited to speak at the Centre for Global Development in Washington D.C., on the radio (Times Radio in the UK and Radio Social in Panama), on podcasts (Veneco Podcast), and at conferences worldwide, including a World Bank conference on migration economics in Lisbon, a workshop at the Free University in Berlin, at the European Political Science Association Conference in Glasgow and the Midwestern Political Science Association Conference in Chicago.

In December 2022, as part of the Migrant Democracy Project, Omar was also awarded a grant from the Mayor of London for the *Civic Data Innovation Challenge* to write a report on the representativeness of local councillors in London, together with Alex Bulat. Joana Naritomi gave a number of invited talks at Harvard-MIT Development Economics, Tufts Economics, Boston University Economics, Seoul National University. She also participated in several conferences at Oxford University on Micro Macro Labour Markets linkages, CEPR Public Economics Symposium and LBS-Stanford Global Tax Conference and participated in policy engagement through an OECD event on Taxation in Developing countries along with researchers from the World Bank and UCLA. Naritomi was appointed to the Advisory Board of the IMDS - Instituto Mobilidade Social (Social Mobility Institute) in Rio de Janeiro, Brazil and was invited to do the keynote speech for the Simpósio Acadêmico de Economia do Setor Público no Brasil (LabPub) at USP, Brazil (University of São Paulo).

Vanessa Rubio-Márquez delivered the keynote address at the first conference of the CIVICA European Polarisation Observatory (EPO), an initiative founded by Sciences Po, the London School of Economics, Bocconi University, and the Central European University. The conference focussed on polarisation at the intersection of cultural and political transformation, with a focus on computational advances and methods. She also participated in a panel with Ilan Goldfajn, the newly appointed President of the Inter-American Development Bank (IDB), at the Overseas Development Institute.

She delivered five conferences to The Royal College of Defence Studies on Mexico's outlook and geopolitics; the Iberoamerican University of Mexico on Polarisation, Populism and Politicisation; the Autonomous University of San Luis Potosí on current challenges for public policy and two more for companies in the energy and platform-transport industries. She was also invited to participate in two international conferences in Berlin and Brussels, on enhancing German-Latin American relations and on the role of the opposition in Venezuela to achieve free and fair elections in the country.

The degree programme complements LSE's mission to embrace new technology and ways of learning to keep the social sciences at the forefront of global thinking, solutions and impact.

As businesses and governments increasingly rely on data-driven decision-making, this competitive new degree programme is designed to equip public policy professionals with the skills to address policy challenges in a world of rapid technological change. Students will hone their quantitative and analytical skills and develop the practical tools and professional experience to be able to confidently address real-world policy challenges.

SPP Dean Andres Velasco celebrated the launch of the new degree programme, noting its relevance for our rapidly evolving society:

"The launch of the MPA in Data Science for Public Policy comes at a perfect time. As the world goes online, there's an increasingly vast data footprint that can be usefully exploited to improve public services, decision-making, and governance. We are happy to launch a new programme about just that."

Students will begin their first year with a dedicated pre-sessional coding bootcamp to learn the foundational skills in Python programming and will benefit from rigorous training in data science, econometrics and quantitative tools, economics and political science throughout their studies. In their second year MPA-DSPP students will apply these skills to a real-world policy problem for an external client as part of a six-month Capstone Project.

The degree is for students who are passionate about quantitative analysis and data as well as policy, public administration and government.

# **New Peruvian Scholarships for Public Service**


Through generous donations, the LSE School of Public Policy has launched the new Peruvian Scholarships for Public Service.



# LSE-Fudan Global Public Policy Hub



The LSE-Fudan Global Public Policy Hub supports collaborative research on global public policy, fosters multi-disciplinary cooperation and fosters collaboration between Fudan University in Shanghai China and LSE. The Hub is a sub-Centre of the LSE-Fudan Research Centre for Global Public Policy, located in Fudan University, and is jointly operated by the two universities. Since its inception in January 2022, the Hub's Research Fellows have worked on a variety of issues relating to healthcare, pension, public opinion and social media analysis in China and comparison across the globe.

In November 2022, the Hub hosted its first Annual Conference "Global Public Policy in the Post-COVID Era", bringing together leading academics in the area of public policy, economics and development. The conference focussed on post-COVID public policy challenges in China, UK and beyond, to provide a cross-country perspective on public policy. LSE Pro-Director of Research Susana Mourato and Fudan

Vice President Zhimin Chen opened the conference. Professor Yijia Jing, Professor of Public Policy and Management from Fudan University, and Professor Bingchun Meng, Director of LSE PhD Academy and Professor of Media and Communications, delivered updates on the collaboration between the two universities.

In addition, the Hub launched a monthly seminar series "China and the World" open exclusively for LSE students. This year's series included seminars on a wide range of topics dealing with economic history, public opinion, healthcare and rural revitalization. Invited speakers included Professor Yuezhi Zhao (Tsinghua and Simon Fraser University), Dr Reza Hasmath (University of Alberta) and Dr Yifei Yan (Southampton University).

This academic year, Research Fellow Dr Yan Wang published a book "Pension Policy and Governmentality in China: Manufacturing Public Compliance" with LSE Press. The book explored how the targeted allocation of benefits, policy experimentation, propaganda and knowledge construction title are used to shape public expectations and justify state rule. The analysis particularly highlights that when active counterconduct (such as resistance) is confined, individuals may choose cognitive rebellion and falsify their public compliance. Dr Wang also published a paper "Pragmatism or Politicism: Local Officials' Decision Making in Social Policy Experimentation" on local officials' decision making in China. The research uses two unique studies on municipal- and county-level government officials in China to investigate their rationale and attention allocation on social policy preferences, as well as their decision making on policy experiments.

Elsewhere, Research Fellow Dr Yuxi Zhang published the journal article "Implementing Public Accounts Committee Recommendations: Evidence from the UK Government's 'Progress Reports' since 2012" that looked at the quality and timeliness of government implementation with a novel dataset built on the Treasury-issued Progress Report. Dr Zhang also coauthored an editorial article "Capturing the COVID-19 Crisis through Public Health and Social Measures Data Science" in the journal *Nature Scientific Data*, where the research groups collected data on government reactions to the pandemic.

## **Growth Co-Lab at LSE**



The Growth Co-Lab seeks to advance empirical knowledge on economic growth and development policy. The research initiative does so by studying and understanding real-life challenges in the developing world, while engaging directly with local policymakers to inform public policies in the quest of shared prosperity.

In collaboration with the Investment Climate Reform Facility (ICR) and the Confederation of Tanzania Industries (CTI), the LSE Growth Co-Lab deployed the Growth Diagnostics Framework to study the drivers of growth in the manufacturing sector of Tanzania and improve the sector's competitiveness. For half a year, the Co-Lab researchers undertook rigorous economic and policy research, participated in a fieldwork visit in Tanzania, and met with experts and relevant local stakeholders in the manufacturing sector, including public and private sector representatives and civil society actors. As a result, the project identified key constraints hindering competitiveness and formulated a policy plan to address challenges comprehensively. Following the release of the findings and recommendations, 44 stakeholders participated in a validation workshop, providing valuable feedback on the study. The final study was also presented to government representatives and other influential organisations who will now use this research to inform public policy in the country.

The Growth Co-Lab has also begun work on the Mozambique Growth Diagnostic Study, which was commissioned by USAID and supported by the IMF, AfDB, and Mozambique's Ministry of Economy and Finance. This study is intended to assist the government in prioritising policies that can unlock the country's economic potential and

foster inclusive growth. To this end, the research team undertook fieldwork visits to collect complementary qualitative data, validate hypotheses, and present findings to 43 high-level officials from the public sector and the international cooperation, and influential actors from the private sector and the civil society. The final study will provide insightful policy implications for the country's current National Development Strategy formulation and will be disseminated in provinces besides Maputo.

Finally, the Growth Co-Lab has continued to capitalise on the public policy experience and motivation of outstanding SPP students, who have begun on-the-ground internships at various Namibian government departments and have also joined the Co-Lab team as research assistants, allowing them to broaden their skills and apply them in real-world scenarios.

## **LSE Cities**



LSE Cities is an international research and educational centre that explores how cities are governed, managed and planned. Through a range of innovative research, education, engagement and advisory programmes, the centre addresses the key challenges facing cities in the twenty-first century and explores governance, policy and design responses, focussing on social equity, climate action and good governance.

This year the centre has consolidated and expanded its activities with an increased focus on executive education aimed at urban leaders from public, private and third sector institutions. Building on the successful Executive MSc in Cities – which attracts urban professionals globally – the centre offers a range of programmes designed to help cities innovate in areas such as urban transport and early childhood development.

A European Cities Knowledge Hub has been established, capturing details about mayors and shedding light on some of their most pressing concerns, such as climate action, transportation, and housing. As part of an ongoing European research collaboration the MyFairShare project is developing a new interdisciplinary behavioural and deliberation experiment in London to examine how mobility budgets can acts as instruments of climate protection policy.

At a more global level, the Council on Urban Initiatives is investigating the need for new policy frameworks and spatial models to deliver equitable housing in response to the UN Sustainable Development Goals and the Emergency Government Initiative has collaborated with international agencies to deliver policy briefs and analytics notes on how to respond to multi-level crises.

The centre is proactively involved with projects that have real-world impact, including collaboration with young people – particularly young women – in the design of public spaces in UK. Research with the LSE Middle East Centre on public space and urban infrastructure in cities of the Middle East has generated policy reports as well as original outreach initiatives on how the public realm impacts on social cohesion.

The centre's pioneering development of urban data and mapping has generated new research and been included in public exhibitions. LSE Cities activities contribute to the intellectual life of the School with high-level public events and involvement in the LSE Festival. It continues to engage with wide audiences through a strong social media presence, blogs and publications, policy roundtables and events.





# The London Consensus – Shaping a 21<sup>st</sup> Century Policy Consensus 4 and 5 May 2023

A generation ago, the so-called Washington Consensus laid out a series of do's and don't for policymakers around the world, and particularly in emerging and developing countries. Today that vision is recognised to have rightly emphasised the need for growth-promoting economic reforms, but also to have fallen short in a number of dimensions-particularly in its neglect of the social and institutional underpinnings that are indispensable not only for achieving sustained growth, but also for building fairer and more cohesive societies. Today, goals such as sustainability, equity and cohesion play a much bigger role in orienting policy design than they did in the 1980s. Global challenges, including climate change, pandemic control and public health more broadly, and the resilience of our economic arrangements have taken center stage. The urgent tasks ahead are political as well as social and economic and political leaders and policymakers need guidance.

Focusing on the twin goals of renewing the social contract and reimagining the state, and drawing from the research and skills of a group of high-profile

scholars, the School of Public Policy hosted a two two-day conference. It sought to build a 'London Consensus' around which new ideas can coalesce, and which can become a «user's guide» for leaders and policymakers, providing practical solutions at the local, national and global levels.

The conference took place on Thursday 4 and Friday 5 May 2023 at LSE.

This event would not have been possible without the generosity and vision of LSE Emeritus Governor, Benefactor and Alumnus Mario Francescotti. His leadership in establishing the Renewing the Social Contract research programme at the LSE launched this process of academic enquiry. Mario's support will also be crucial for turning the papers into a conference volume, and for the follow-up dissemination opportunities.

Stay tuned for the ensuing website and publication to be released in Spring 2024.


