

### The Programme

In keeping with LSE traditions, the MSc International Social and Public Policy will bring together academic rigour and in-depth understanding. The programme is designed to provide students with advanced postgraduate education in the theory and practice of social & public policy. The programme enables students to engage in new ways of thinking about how best to meet human needs and increase wellbeing. It equips students with core understanding of central issues of social & public policy development, of the inequalities in policy drivers and outcomes, and of the interrelationship between the state, market, family, NGOs / civil society and international organisations in provision, organisation and funding. It is underpinned by the LSE approach to social and public policy that is explicitly international, interdisciplinary and applied.



You will be joining a class of academically excellent students from across the globe and from a range of backgrounds. The diverse experience and international perspectives which your classmates will bring to the programme will enhance your learning both in and out of the classroom. Some will also bring fascinating insights from their employment experience in public, non-governmental, and private sector organisations.

## **Subject Specialisms**

As an LSE-Fudan double-degree student, in year one, you will follow the MSc International Social and Public Policy General stream at LSE, and then in year two, you will proceed to Fudan where you will follow the Masters in Management in Public Policy.

Please be aware that the LSE-Fudan double degree has some specific requirements for completion of the two degrees:

A student who has completed year one and is unable to complete year two of the programme in Fudan will not receive an interim award.

A student who has successfully completed year one, but who can produce evidence of very exceptional circumstances requiring that they withdraw from year 2 of the degree may seek permission from both LSE and Fudan University to transfer onto the MSc International Social and Public Policy degree at LSE.
