The Bloggers Meet was a pre-Summit interactive meeting between members of the LSE South Asia Centre, Aman Foundation and a team of dedicated bloggers who were going to blog and Tweet live through the Summit. Panel 1: Philanthropy & Institution-Building

Pakistan has a rich tradition of generous philanthropy for social benefit and impact. The inaugural panel considered the role of philanthropy as a ballast for institution-building in Pakistan. Panelists included representatives from established philanthropic institutions, new and recent initiatives, and expert analysts of philanthropy in Pakistan. The discussion covered several aspects, from areas of need and deprivation to the challenges and limits to philanthropy in a country like Pakistan. An animated Q&A raised further issues of the role of the state in institution-building, how governments can work by incentivising and partnering with philanthropic initiatives, and the successes and prospects of supporting minority groups.

Pakistan's engagement with art has often overlapped with a certain modernity that is embedded in the particularities of that society. This has made art in all its forms the agency to represent challenges and change through different artistic modes.

Experts from the fields of fine art, film, media and advertising discussed different ways in which art is a carrier of social issues, and has fundamentally impacted on Pakistan's sense of selfhood and identity. Most importantly, the panel discussed art as a space to protest against injustices, and to raise consciousness.

The Q&A revealed how the common person views art in Pakistan, how more needs to be done to integrate the role of art in social change, and how art can be a constructive echo chamber of society at large.

Dinner at DHA Golf Club

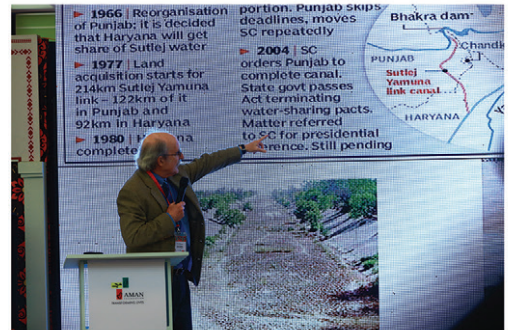

Professor David Gilmartin delivered a pre-Dinner talk on 'The Indus Basin and Its People: The River Basin and the Imagining of Pakistan' at The Convention Centre, DHA Golf Club, which was followed by a brief Q&A. Gilmartin's latest book *Blood and Water: The Indus River Basin in Modern History* (2015) is the first sustained examination of the intersection between environmental and political history in the region over the last two centuries.

This panel debated the several issues that concern the Constitution in Pakistan today, and considered a range of topics including its relevance to governance and deepening democracy in Pakistan. Particular attention was paid to the 18th Amendment (which has had widespread support), examining its value regarding the specificity of Pakistan's contemporary requirements. The issue of the roles of the central government and its constituent regional governments is an issue of global significance across democracies and – amidst a charged Q&A – the panel explored if Pakistan's model of greater federalism could be a useful learning curve.

The final panel discussed the vexed question of 'development' and its indices in different sectors in Pakistan. Taking a long-term, and occasionally comparative view, experts discussed sectoral investments and outputs, and the related causes of success and failure of the developmental trajectory of Pakistan from the perspective of both state and non-state actors. The Q&A unravelled these issues in greater detail, as members of the audience shared their own experiences and opinions in the field of development.

Closing Remarks: 'A World in Tumult'

Dr Maleeha Lodhi, Pakistan's Ambassador to the UN and an alumna of LSE, sent pre-recorded Closing Remarks for the Summit. Regretting her inability to be present at the Summit – she had to cancel her travel at the last moment because of work commitments – Dr Lodhi hailed the efforts of the South Asia Centre to host a commemorative Summit in Pakistan. Commenting on the themes chosen for discussion, she said that each was marked by the immediacy of their importance, and such platforms for free and frank conversation was where the future of Pakistan could be imagined and debated. Dr Lodhi also spoke at some length on the several crises confronting the world in general, and the central role that Pakistan can play in alleviating them.



11 April 2017

Press Conference at The Avari Towers

Highlighting the success of 'Pakistan at 70', the first such international Summit to be held in Pakistan by a foreign university, the Press Conference was addressed by the core team of organisers and alumni. Dr Mukulika Banerjee (Director, LSE South Asia Centre) and Ms Fayeenza Naqvi (Co-Founder & Chair, Aman Foundation) introduced the purpose of the Summit, the mutual and shared interests of the two institutions, and the partnership that made the Summit possible. Replying to questions from the Press and the media, they explained how this Summit was the first of several initiatives to create debates in Pakistan about Pakistan. Malik Ahmad Jalal (CEO, Aman Foundation), Dr Nilanjan Sarkar (Deputy Director, LSE South Asia Centre) and Mr Ali Jameel (LSE Alumnus) also addressed the Press corps.
