About the Director

Peter Trubowitz is Professor of International Relations at LSE and Associate Fellow at Chatham House, the Royal Institute of International Affairs. His main teaching and research interests are in the fields of international security and foreign policy, with special focus on the United States. He has written widely about the ways domestic politics have shaped America's approach to the world since its founding, and about how geopolitics, globalisation and other international forces have influenced and shaped American political development and contemporary US politics.

Professor Trubowitz's scholarly publications include *Politics and Strategy: partisan ambition and American statecraft* (Princeton University Press) and the prize-winning *Defining the National Interest: conflict and change in American foreign policy* (University of Chicago Press), as well as articles in scholarly journals such as *International Security, International Studies Quarterly* and *Perspectives on Politics* and more popular titles including *Foreign Affairs, International Affairs* and *The National Interest.*

An award-winning teacher, Professor Trubowitz has lectured on international affairs to universities worldwide as well as to government bodies, think tanks and private companies. A frequent television guest on major international media outlets such as Bloomberg, CNBC and BBC, he has undertaken research supported by grants and fellowships

Before joining the LSE, Professor Trubowitz was Professor of Government at the University of Texas at Austin. He has also held visiting academic positions at Harvard University, Princeton University, the University of California at San Diego, Universidad de Chile, Centro de Investigación y Docencia Económicas (CIDE) in Mexico City, and the Beijing Foreign Studies University, where he was the J. William Fulbright Distinguished Lecturer in American Foreign Policy.

Professor Trubowitz is currently working on a book, *The Retreat of the West: globalism, nationalism and the liberal order* (Oxford University Press), about the rise of anti-globalism in the West and what it portends for the future of the liberal world order.

John Phelan's relationship with LSE goes back to 1985 when he studied economics and international relations on the General Course – LSE's study abroad programme – which he undertook while studying for his BA in Economics and Political Science at Southern Methodist University (SMU) in Texas. He received an MBA from Harvard Business School in 1990.

John is Co-Founding Partner and Chief Investment Officer of MSD Partners and MSD Capital, a private investment firm established in 1998 to exclusively manage the capital of Michael Dell, the Chairman and Chief Executive Officer of Dell Technologies, and his family.

John serves on multiple advisory boards, including the Board of Trustees of the Whitney Museum of American Art, the Spirit of America, and the Aspen Art Museum (as Chairman). He also serves on the Board of Dean's Advisors for Harvard Business School, the Investment Committee for the SMU Endowment and LSE's North American Advisory Board.

As longstanding supporters of the School, John and his wife Amy have given generous



contributions to the US Centre's popular public events lecture series, and funded more than 30 General Course, MSc and PhD scholarships at the School.

In April 2021, John gifted \$10 million (USD) through the John and Amy Phelan Foundation to endow the US Centre and to foster its commitment to outstanding scholarship, teaching and public engagement on US affairs.





As part of our programme of scholarly research and engagement, in 2020-21 Centre faculty have held conferences and seminars, such as 2020's Race and Gender in US Politics in Historical and Contemporary Perspective series, and our 2021 conference on Single-Parent Families. These conferences and seminars bring together scholars from the US, Europe and LSE, and help train and professionalise postdoctoral fellows and PhD students at the School.



In 2020-21, the Phelan US Centre has continued to make connections with a wide audience via our far-reaching, innovative digital platforms. Through our daily USAPP blog, podcast series, explainer videos, and our award-winning digital project The State of the States, we provide a growing global community of hundreds of thousands of people with easily accessible and academically grounded commentary and analysis on the US and its role in the world.

USA Politics and Policy (USAPP) blog

About LSE USAPP

The LSE Phelan US Centre's USAPP blog

is our online platform where academics, activists, policymakers and others come together to discuss the current challenges facing the US. The blog's aim is to make social science research on topics from COVID-19 to political polarisation relevant by translating it for a wide audience including policymakers, students, activists and other interest groups.

Blog content consists of commissioned pieces based on recent academic journal articles or requests for comment on current events from experts in the US, UK and elsewhere; on current events; unsolicited submissions from academics and others; and reposts from other LSE blogs. In 2020-21, USAPP published 170 original articles, and cross-posted over 100 academic book reviews

and other articles from other LSE blogs.

Since 2018, the USAPP blog has supported the research for, and the development of, the Phelan US Centre's award-winning digital project, The State of the States.

Reach and Impact

■ The USAPP blog is now widely seen as an authoritative source of accessible information and commentary on US politics and policy. In 2020-21, articles published on LSE USAPP were mentioned in media outlets including the Financial Times, Vice, The Washington Post, Bloomberg, The Conversation, The Hill, Bangor Daily News, Politico, Vox, City Observatory, The Daily Signal, and a United Nations report on drug policy. We are also aware of academics in the US and the UK using USAPP resources as part of their curricula.

The Ballpark podcast

About The Ballpark

The Ballpark is the Phelan US Centre's regular podcast series which explains US politics, policy and society to a wide, non-academic audience. Since 2016, the Phelan US Centre has released 35 episodes of The Ballpark and 31 episodes of The Ballpark: Extra Innings, featuring event recordings, interviews with high-profile academics and experts on US politics and policy, and topic-based explainers.

As part of The Ballpark, the Phelan US Centre also produces the regular podcast series The State of the States. With eight episodes already released, and a new series planned for 2021, these podcasts take a deep dive into the policy and political issues facing specific American states.

Launched in March 2021, The Politics of Race in American Film podcast builds on the

research of Dr Clive Nwonka, Centre Affiliate and LSE Fellow in Film Studies in the Department of Sociology. The four episodes released to date examine how racial politics in America are represented by its films, Hollywood cinema's role in how race is framed, and how this framing has contributed to broad, intersectional representations of racial inequality.




An outgrowth of the Phelan US Centre's USAPP blog, **The State of the States** project is an online portal that explores and explains politics and policy issues across all 50 states and Washington, DC. It's a unique, free to use, apolitical resource aimed at students, academics, local government practitioners, and those working in charities and other non-governmental organisations.

Reach and Impact

■ In April 2019, The State of the States won a Guardian Universities Award in the digital innovation category. In 2020, spurred on by this success – and the need for the platform to become sustainable – the Phelan US Centre entered the project into the SUCCESS programme, funded by Research England, which aims to commercialise academic work.

The project was also subsequently funded by LSE Research and Innovation to create a new platform in the summer of 2021. This new platform will continue to focus on providing state politics and policy data, but it will also provide case studies of US state policy effectiveness, which users can interact with and comment on. These case studies will aid those working in US state government to do their jobs better by providing them with easily accessible examples and policy learning points.



Student Programmes

In 2020-21, the Phelan US Centre has continued to run programmes that enhance the experience of LSE students. Through our undergraduate and PhD-focused student programmes, we encourage US-related interdisciplinary research and support the development of early career scholars at LSE.

Undergraduate Research Assistantships

With the generous support of LSE alumni, the Centre's popular Undergraduate Research Assistantship programme allows students to collaborate with Centre faculty affiliates on their academic research. Students are paired with academics who require assistance in collecting or processing new data, gathering archival resources, conducting library research, or writing up blog articles.


